Sheriff's Office seeks sexual assault suspects

The Iredell County Sheriff's Office is seeking help to locate two sexual assault suspects.

According to a Sheriff's Office press release, a warrant has been issued for **Jose Louis Garcia**, 28, of Cleveland in connection with the 2004 sexual assault of a 9-year-old girl in eastern Iredell County. Garcia faces charges of first degree sex offense with a child and indecent liberties with a minor.

The Special Victims Unit has made attempts to locate the suspect at various residences, but has been unable to do so.

An arrest warrant has also been issued for **Teofilo Espinoza** of Cornelius, in connection with an alleged sexual assault that occurred on March 20.

Espinoza faces charges of statutory sex offense and indecent liberties with a child.

According to the Sheriff's Office press release, the teenage victim filed a report March 22, and upon further investigation, Espinoza was named the suspect.

Detective Sgt. Brian Fink discovered Espinoza was using a false Social Security number previously issued to a Hispanic male who had been deported.

The Immigration and Customs Enforcement Office in Charlotte has been asked to assist in the case.

Tarboro man charged with drug trafficking

A Tarboro man was arrested this week and charged with trafficking cocaine and methamphetamine.

Guillermo Espinosa, 38, of 31 Booth Lane in Tarboro was arrested on March 11 following a joint investigation by the Edgecombe County Sheriff's Department, the N.C. Alcohol Law Enforcement and the N.C. State Bureau of Investigation, authorities said.

Espinosa was being held in the Edgecombe County Detention Center. He's charged with possession with intent to manufacture, sell and deliver methamphetamine, felony maintain dwelling place for controlled substances and conspire to sell methamphetamine.

Following a vehicle stop and search of Espinosa's residence, 45 grams of cocaine, 25 grams of crystal methamphetamine and a 2004 Lincoln Navigator were seized.

This is the first seizure of that type of meth in Edgecombe County, authorities said. Espinosa is being held on a \$500,000 secured bond.

Brunswick authorities arrest 5 in alleged cocaine ring

The Brunswick County Sheriff's Office's Drug Enforcement Unit ended a three-month investigation last week with the arrest of five people on drug-related charges and the seizure of cocaine and more than \$180,000 in cash.

Agents from Brunswick County, South Carolina and the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives, served a search warrant March 25 at a residence in Loris, S.C., where they found the cash, a stockpile of weapons and more than two kilograms of cocaine, according to a news release from the Brunswick County Sheriff's Officer.

The suspects there were armed, and agents seized several handguns, assault rifles and shotguns, along with hundreds of rounds of ammunition during the search, the news release said.

The Brunswick County drug unit had been investigating a drug trafficking organization operating in the southern end of the county when agents learned the organization was rooted in South Carolina.

Agents in both areas worked together to find the hub of the drug operation in Loris, which was believed to be responsible for hundreds of thousands of dollars of cocaine being distributed throughout North Carolina and South Carolina.

Zacarias Gomes Espinosa, 34; **Jorge Rivera Albarran**, 47; and **Esteban Rivera**, 18; were each charged with trafficking cocaine, trafficking in ice, crank or crack, and possession of firearms by an unlawful alien. Christopher Jerome Elleby, 29, was charged with trafficking cocaine and trafficking in ice, crank or crack. **Roberto Fonesca**, 30, was charged with trafficking cocaine.

Immigration officials tight-lipped about 15-person arrest last week

Beaufort County- Federal and local authorities are disclosing little about the year long investigation that resulted in the arrest last week of the owner and 14 employees at Jade Garden restaurants in Beaufort and Bluffton.

"This is very much an ongoing criminal investigation," said Barbara Gonzalez, regional spokeswoman for U.S. Immigrations and Customs Enforcement. "There are no new developments and no new information to release."

Beaufort County Sheriff P.J. Tanner referred questions about the case to ICE and declined to comment on what led authorities to believe the restaurant was hiring illegal immigrants.

On March 23, ICE officials and members of the Beaufort County Sheriff's Office executed search warrants at Jade Garden's Beaufort restaurant on Boundary Street, at the Bluffton restaurant on Fording Island Road, at three homes in Bluffton and at two homes in Beaufort, according to Gonzalez. All were arrested and charged with being in the U.S. illegally.

The 15 people, all adults, hail from various countries. **Six are Chinese men, four are Chinese women, four are Mexican women and one is a Guatemalan man**, according to ICE.

They remain in custody, Gonzalez said. She declined Friday to release their names or where they were being held.

The U.S. Attorney's Office has not determined whether federal charges will be pursued against the owner or the workers, Gonzalez said.

The owner of the restaurant -- **Ai Hui Huang**, according to Beaufort County's business license database -- **is an ICE fugitive** and probably will be deported based on a previous deportation order, according to Gonzalez. Gonzalez would not provide details of that order on Friday.

Suit alleges illegals hired to drive down wages

A now-closed local chicken plant was among 16 Perdue Farms Inc. sites where illegal immigrants were routinely hired to depress wages for Americans, according to a recent lawsuit.

Three law firms claim in the racketeering complaint, which they hope to be declared a class-action suit, that Perdue Farms managers engaged in a scheme to drive down wages for legal plant workers in the Carolinas, Alabama, Delaware, Georgia, Indiana, Kentucky, Maryland, Tennessee and Virginia.

"The scheme saves Perdue millions of dollars in labor costs because illegal immigrants will work for extremely low wages, will typically not complain about workplace conditions and injuries, and, because of their vulnerable situation, will accede to employer demands to work harder and longer than American citizens," the suit states.

Privately held Perdue Farms did not return calls Friday to the family-owned company's Maryland headquarters.

The federal suit, filed last month in Alabama, doesn't name Perdue Farms as a defendant. Instead, various personnel managers are alleged to "have conspired with others in Perdue's headquarters in Salisbury, Maryland" to carry out the scheme.

The suit claims the hiring practices, which included knowingly employing workers with false identities, have been in place at the plants since March of 2006.

The Fayetteville plant named in the suit closed in September 2006. The chicken processor sold the 13,552-square-foot building on Tom Starling Road for \$450,000 last year to a Kernersville company, according to Cumberland County records. The asking price for the 13-acre property had been \$715,000, according a Fayetteville-Cumberland County Chamber of Commerce listing.

The suit claims Perdue Farms was able to hire legal workers "for depressed wage rates" at the Fayetteville plant because of "its size and power within the local labor market."

The employment of undocumented workers also occurred in North Carolina at Perdue Farms plants in Concord, Lewiston and Rockingham, according to the suit.

The company's hiring practices in North Carolina have been called into question before.

The U.S. Labor Department sued Perdue Farms in 1999 for not compensating crews for their travel time while hauling chickens from farms to the Lewiston plant. Perdue Farms settled the suit by paying \$305,235 in overdue compensation with interest and agreeing to reform its overtime policies.

ICE arrests illegal alien gang members in Asheville, NC

Over a four-day period, Immigration and Customs Enforcement, along with the Henderson County Sheriff's Office and the Buncombe County Sheriff's Office carried out targeted raids throughout the Asheville area, which resulted in the arrest of 26 violent gang members, several of whom are illegal aliens.

In addition to immigration violations, many of those arrested, were charged with crimes ranging from violent assaults to drug trafficking. ICE agents also seized marijuana and cocaine from multiple locations.

ICE apprehended illegal aliens from Mexico, El Salvador, Guatemala and Honduras. The gangs involved were Surenos, Bloods, M Zone Rydas and Sugar Loaf Clique 31.

In recent years, Asheville has become inundated with illegal aliens. Consequently, crime and gang activity has increased in the once quiet town, nestled in the mountains of western North Carolina.

Illegal Immigrant Charged With Child Sex Crimes

FAYETTEVILLE, N.C. -

An illegal immigrant from Mexico has been charged with sexually inappropriate behavior **with a 6-year-old girl**, according to officials.

The Cumberland County Sheriff's Office say 28-year-old **Elio Citala-Rodriguez** of Pink Hill, N.C. is a distant relative of the victim. Detectives say the alleged encounters happened between March 2006 and Sept. 2007 while Rodriguez was living with the victim and her parents in Fayetteville.

Officials say the victim was forced to have sexual intercourse and engage in other sexual favors with Rodriguez.

Rodriguez has been charged with first degree statutory rape, first degree statutory sex offense and taking indecent liberties with a child. More charges are expected to be filed against the suspect by the Pink Hill PD, according to a press release.

He is being held in the Cumberland County Detention Center under a \$100,000 secured bond. Rodriguez is also being retained by Immigration Custom Enforcement.

Man sentenced for passing counterfeit bills

A North Carolina man has been sentenced to eight months in prison for passing counterfeit \$100 bills throughout the Southeast, including in Fayetteville.

Rene Amador Castillo, 59, of Raleigh, was sentenced Tuesday by U.S. District Court Judge Terrence Boyle, according to a news release from U.S. Attorney George E.B. Holding.

Castillo pleaded guilty in November to conspiring to pass and utter counterfeit bills. It was part of a plea agreement in which he stipulated he was responsible for losses exceeding \$70,000.

Castillo's sentence will be followed by three years of supervised release, according to Holding, and subjects him to possible deportation. He also has to repay \$59,900 to 28 known victims.

Castillo is a native of Peru. The high-quality, counterfeit bills he passed off on merchants were known as "Peruvian" notes because they were made in the South American country, according to the release.

According to investigators, Castillo and conspirators distributed more than \$82,000 in counterfeit bills throughout the Carolinas, Washington, D.C., Maryland and Georgia.

The U.S. Secret Service in Raleigh began investigating the counterfeit notes in early 2009, after multiple merchants there reported receiving the bills.

Brunswick County | A man from Honduras who escaped from the Brunswick County jail Sept. 27 by impersonating another inmate was returned Thursday after his November arrest in Maryland.

Rosher Rodriguez-Aguilar, 27, is charged locally with one count of obtaining property by false pretense, one count of identity theft and one count of misdemeanor escape local jail, according to a news release from the Brunswick County Sheriff's Office. He is scheduled to be in Brunswick County Superior Court on Monday on those charges.

Rodriguez-Aguilar is in the Brunswick County jail in lieu of a \$25,000 bond. In addition, U.S. Immigration and Customs Enforcement has a retainer on Rodriguez-Aguilar, according to the release from Sgt. April Stanley of the sheriff's office. The retainer means that after Rodriguez-Aguilar served time for his original charge, he would be taken into custody by immigration officials.

In addition to an alleged immigration violation, Rodriguez-Aguilar was arrested in Brunswick County in 2009 on allegations of driving while impaired and failure to appear in court. He had been in the jail in lieu of a \$4,000 bond since Sept. 17.

Rodriguez-Aguilar made his escape by impersonating another inmate scheduled for release on Sept. 27.

CUMBERLAND COUNTY — **Claudio Gutierrez-Cruz** is wanted for shooting and killing 44-year-old Francisco Lopez Batista on the premises of Fort Bragg.

The FBI told NC WANTED that Gutierrez-Cruz had contracted with Fort Bragg to collect pine straw on a particular piece of property.

On June 14, 2005, investigators say Gutierrez-Cruz told them he was finished fishing with his young son and was driving in the Fort Bragg area when he spotted three individuals collecting pine straw on that piece of land that was designated for his stockpile of pine straw.

According to witness statements, Gutierrez-Cruz grabbed his shotgun, aimed it at Batista and fired. His wife, Veronica Torres, said her husband had fired a shot in the air, but when the pellets came down to earth, they hit Batista.

Batista was shot in the abdomen and thigh. He received medical attention, but died the next day. "This man stole and stole and stole from us," Cruz' wife said in a June 2005 TV interview.

Authorities determined Gutierrez-Cruz premeditated the crime. They say he maneuvered himself into a position that gave him direct aim at the victim. "The shot was fired to harm, injure or kill Batista, which ultimately happened," said FBI Spokesman Ken Lucas.

Gutierrez-Cruz was eventually charged with first degree murder on federal property, and unlawful flight to avoid prosecution.

Gang suspect goes on trial in double homicide case

A suspected MS-13 gang member charged with committing two murders is scheduled to go on trial for his life in Charlotte today.

Alejandro Umana, 25, is also charged with conspiring to extort money from Charlotte drug dealers to increase MS-13's revenues and to intimidate witnesses to prevent them from cooperating with law enforcement authorities investigating the gang's activities.

Umana is accused of killing two brothers in a restaurant in Greensboro in December 2007. He killed them, prosecutors allege, to maintain MS-13's reputation and to advance his position within the gang's criminal enterprise.

Prosecutors have said they will introduce evidence during the trial that Umana also killed two men in Los Angeles in 2005 and participated in a third killing in that city that same year.

Umana was among 26 suspected MS-13 gang members indicted in Charlotte in 2008. Prosecutors alleged that the gang was part of an international organization that committed crimes across Charlotte, including robbery, racketeering, extortion and murder.

Umana is the last of the suspected MS-13 gang members arrested in the 2008 sting to face prosecution. Eighteen of them have pleaded guilty.

Six gang members were convicted in January on a variety of charges involving violence and conspiracy. One was convicted of murder in connection with the April 2008 slaying in Charlotte of Ulisses Alejandro Mayo, who was shot to death while sitting in a car after a children's birthday party.

The 24 defendants are awaiting sentencing.

The remaining defendant is imprisoned in El Salvador and can't be extradited.

The Salvadoran gang has as many as 12,000 members across the country. MS-13, also known as La Mara Salvatrucha, is an abbreviation deriving from the word "Mara," which means "gang." Salvatrucha combines "Salva" for Salvadoran and "trucha," which is slang for "fear us."

26 gang members, associates arrested following 4-day targeted operation

ASHEVILLE- Gang members, associates and other law violators were arrested in Asheville, North Carolina, following a four-day multi-agency law enforcement dragnet by U.S. Immigration and Customs Enforcement agents, the Henderson County Sheriff's Office and the Buncombe County Sheriff's Office.

Twenty-six individuals were arrested as a result of this operation with 19 suspects facing state criminal charges and seven facing immigration administrative charges. The criminal charges range between violent assault offenses -- which include stabbing incidents -- to narcotics violations. Agents also seized marijuana and cocaine.

Those arrested, which included U.S. citizens, were from various countries including **Mexico, El Salvador, Guatemala and Honduras**. Some were gang members or associates of the Sureños, Bloods, M Zone Rydas and Sugar Loaf Clique 31.

The arrests occurred at various locations to include Oriental Pavilion, a nightclub known as a gang hangout, which was operating illegally.

The North Carolina Alcohol Law Enforcement (ALE), the North Carolina State Probation and the North Carolina Department of Motor Vehicles played a critical law enforcement role in this targeted operation. ICE's Gang Unit identifies violent street gangs and develops intelligence on their membership, associates, criminal activities and international movements to deter, disrupt and dismantle gang operations by tracing and seizing cash, weapons and other assets derived from criminal activities.

Bonilla and two of his three passengers — all adults — were taken to Alamance Regional Medical Center with injuries that weren't considered life threatening, Deardorff said.

Shooting case leads to prison term, deportation

An act of shooting at tractor-trailers on a major local highway last year has led to a lengthy prison sentence and eventual deportation for one of two brothers involved.

Emilio Rubio-Gonzalez, 25, of Kernersville, received a 58-year term in a recent session of Carroll County Circuit Court after pleading guilty to several charges in connection with the incident.

It occurred on Interstate 77 in Carroll County near the North Carolina/Surry County border during the early morning hours of April 16, 2009.

Random shots were fired at three-tractor trailers from a speeding car with its headlights off, authorities have said, causing damages but no injuries.

A multi-state investigation led to warrants on attempted murder and other charges being issued against both Emilio Rubio-Gonzalez and his older brother, **Leon Rubio-Gonzalez**, 27, of Boone.

Emilio Rubio-Gonzalez was apprehended last May after a traffic stop in Alabama, but the elder suspect is still at large. The car they used during the shooting was recovered in North Carolina.

The younger brother was indicted on three counts of shooting into an occupied vehicle and two counts each of attempted second-degree murder against Jimmie W. Grunden and Mark E. Hunley and use of a firearm in the commission of a felony.

After he pleaded guilty to those violations in a recent session of Carroll Circuit Court, Rubio-Gonzalez drew the 58-year sentence, of which he will serve nine years in the Virginia Department of Corrections.

Rubio-Gonzalez then will be released into the custody of U.S. Immigration and Customs Enforcement (ICE) and deported.

\$800K in illegal drugs seized in major sting

Federal investigators seized more than \$800,000 worth of illegal drugs, and approximately 50 people from Nash and Wilson counties have been sentenced to federal prison in a major drug trafficking sting called Operation Cold Wind, authorities announced Tuesday.

Agents also seized nearly \$500,000 in cash, 35 firearms and three vehicles during the three-year investigation, U.S. Attorney George Holding said at a news conference in Wilson.

"A clear message to drug dealers has been sent that, if they decide to ply their trade here in this judicial district, they can expect to be prosecuted to the fullest extent of the law," Holding said.

The investigation involved the movement of crack cocaine and powdered cocaine into Nash and Wilson counties, where it was then distributed to mid-level narcotics traffickers.

It is part of a bigger drug ring with ties across the U.S. and into Mexico.

The Henderson County Sheriff's Office Violent Crime Unit has obtained a warrant charging an illegal alien with first-degree murder in the 2006 shooting death of another man.

Police say Hernandez-Meza shot Perez four times. Both were in the country illegally, according to the Sheriff's Office.

The men were close associates and the murder was the result of an ongoing confrontation, the Sheriff's Office said.

Perez lived in a mobile home park off Flintwood Lane in Mountain Home, and his body was found in the front yard of a neighboring mobile home, police said in 2006. Perez was identified by family members after news of the murder broke.

The suspect was identified through forensic examinations and witness statements. The victim and suspect have criminal histories in multiple counties in Western North Carolina, police said.

The Sheriff's Office did not have enough information at the time of the murder to make an arrest, the release said, adding that the case was further complicated by the fact that Hernandez-Meza was nowhere to be found and sources indicated that he had gone back to Mexico.

Jury urges death for gang member

A federal jury in Charlotte on Wednesday recommended that **MS-13 gang member Alejandro Umana** be sentenced to death for the 2007 murders of two brothers in Greensboro.

Umana, 25, was convicted of murder last week in connection with the slayings of Ruben Garcia Salinas and Manuel Garcia Salinas in a family restaurant in Greensboro.

Chief U.S. District Judge Bob Conrad must follow the jurors' recommendation and impose the death sentence. Umana, who authorities say was a member of an MS-13 cell in Charlotte, will probably be sentenced in the next few months.

Umana was one of **26 suspected MS-13 gang members** indicted in Charlotte in 2008. Authorities said the gang was part of an international organization that committed crimes across Charlotte, including murder, robbery, racketeering and extortion.

Eighteen have pleaded guilty. Six gang members were convicted in Charlotte in January on federal charges involving violence and conspiracy. One was convicted of murder in connection with the April 2008 slaying in Charlotte of Ulisses Alejandro Mayo, who was shot to death while sitting in a car after a children's birthday party.

The remaining suspected gang member is imprisoned in El Salvador and can't be extradited.

Robbins Men Face Felony Cocaine Charges

An undercover drug investigation in the Robbins area led to the seizure of 88 grams of cocaine and the Wednesday arrest of two men.

Oscar Moreno Valenzuela, 24, of 103 Bear Creek Lane, and **Salvador Gasca Ochoa**, 34, of 452 East Lindale Drive, were both charged with three counts of felony trafficking cocaine, felony possession with intent to sell or deliver cocaine, felony sell cocaine and felony deliver cocaine, according to a press release.

The investigation was conducted by officers from the Moore County Sheriff's Office narcotics unit in December 2009 and January 2010, according to the release.

Both men were placed in the Moore County Detention Center, with bail set at \$250,000 for each.

WASHINGTON — U.S. Immigration and Customs Enforcement (ICE) and its law enforcement partners arrested **596 foreign nationals with criminal records** during a three-day enforcement surge throughout the southeastern United States, making it the biggest operation targeting at-large criminal aliens ever carried out by ICE in the region.

During the operation, which concluded late last night, ICE officers and agents worked in teams with the U.S. Marshals Service, U.S. Customs and Border Protection, and local law enforcement agencies in Florida, Georgia, South Carolina, **North Carolina**, Arkansas, Alabama, Louisiana, Mississippi, Tennessee and Puerto Rico.

Department of Homeland Security Assistant Secretary for ICE John Morton cited the operation – which involved nearly 400 federal and local law enforcement officers and agents – as another example of ICE's focus on indentifying and removing criminal aliens from the United States.
