County seizes cocaine worth around \$500,000

STOKES COUNTY- A collaboration between the Drug Enforcement Administration and the Stokes County Sheriff's Office resulted in the seizure of five kilos of cocaine and three firearms from a house in Madison on Monday night.

According to Sheriff Mike Marshall, the street value of the five kilos could easily be \$500,000 depending on the purity of the cocaine. Also seized from the house were two rifles and a handgun.

Ines Ovidio Marinero, 29, of K-Fork Road, Madison, was arrested on Monday just after 9 p.m. and **charged** with felony trafficking cocaine and felony maintaining a drug dwelling. He was placed in the Stokes County Jail under a \$500,000 secured bond.

Marshall said this was a large bust for the county, as it is unusual to find and seize that much cocaine here. He said, "This is why we work as hard as we do in trying to locate and stop drug dealers from building their drug business here in our county. Drug dealers are working hard to destroy our families and our children with their illegal narcotics."

The sheriff said he is pleased with the success of the operation, especially when he thinks about how many kids' hands the drugs are being kept out of. He said his narcotics officers work hard to collaborate with other agencies to get as many drugs off the street as possible.

He continued: "We are grateful for the great job our DEA has done in this case, and we will continue to work hard with our fellow agencies in seeking out and charging drug dealers that find their way into Stokes County."

As of Tuesday afternoon, officers were still looking into Marinero's citizenship status, the registration status of the firearms, and if Marinero had a previous criminal history.

Cocaine is usually sold by the gram, by 3.2-gram amounts called "eight balls," or in ounces. There are 28 grams in an ounce, 16 ounces in a pound, and 2.2 pounds in a kilo. So nearly 5,000 grams or small user amounts could have come out of the five kilos. Based on the purity factor and distribution levels, the street value of cocaine can range between \$100 per gram to more than \$130 per gram. The sheriff's office will know the full extent of the worth of the five kilos once lab results are in.

Marshall stated, "Even though it may look like you can make a lot of money as a drug dealer, the reality is, it brings destruction to our society, it is killing our family members and destroying homes."

Man charged with series of shootings, one a fatal

DURHAM -- Police today charged a 26-year-old man in connection with a series of shootings at an East Durham apartment complex that left one man dead and two others injured.

Members of the U.S. Marshals Service's Fugitive Task Force captured **Jose David Mendoza** of Hearthside Street around noon today at the Red Roof Inn on N.C. 55, according to the Durham Police Department.

Police have charged Mendoza with the March 28 shooting death of Jesus Contreras, 37, who also resided on Hearthside Street.

Investigators have not yet said what led to the shooting, but they had said that it was not a random act.

The shootings occurred just after 7 p.m. at 4 Welch Place at the Hearthside Apartments near Lawson Street, between Durham Community College and N.C. Central University.

Emergency workers who arrived at the apartment complex rushed three shooting victims to Duke University Hospital for treatment.

Two of the victims suffered injuries that were not considered life threatening. Contreras died at the hospital, police reported.

Police arrest man who tried to kidnap girl

Charlotte, N.C. — An 18-year-old North Charlotte man is scheduled to appear in court Thursday afternoon on charges he tried to abduct a 7-year-old girl outside her home.

Matthew Cruz is charged with kidnapping and assault on a child under 12.

Neighbors said the Long Creek Club Apartments are normally safe, and any screams are from the children playing outside.

Patrick Bailey heard a little girl yelling early Saturday evening and told Eyewitness News he thought it was simply children horsing around.

"I heard her screaming," Bailey said. "She's got an older brother and a younger sister, so I figured she was just playing around."

Bailey was horrified when police told him his neighbor's daughter was almost kidnapped.

The girl's mother, Gabriella Milak, said her daughter was in tears when she ran home.

"She just said a guy grabbed her, started to run with her and she was scared," Milak said. "She said she had the feeling that somebody wanted to kill her. She was scared. I was absolutely shocked that it happened so close to home. It was just a few feet away from the windows."

Milak said her daughter told her the man had been walking around where children were playing outside, waving and saying "hello" before grabbing her. She said the children did not recognize him.

"They were looking at him like a little suspicious and stuff like that," Milak said.

Geza Milak, the little girl's father, said if it weren't for a neighbor who saw what happened, things could have ended much differently.

His daughter told him that neighbor turned around when he heard her screams and looked right at the man as if he were about to come after them.

That's when, she said, the suspect let her go and ran around a building.

"We thank him from the bottom of my heart because he's the one who saved my daughter's life, actually. Thank God," Geza Milak said.

The little girl was not injured.

SALISBURY — A 23-year-old woman was airlifted to a Winston-Salem hospital after police said a drunk driver ran off the road and hit her Saturday night.

Officers found the driver, Cesar Rojas, near the crash scene shortly after arriving, an arrest report said. He was immediately taken into custody.

Christie Michelle Myers Waller, of Cypress Lane, was found lying in a nearby ditch in the 500 block of Gold Hill Drive.

Salisbury Police said Rojas, 23, was turning from Carolina Boulevard onto Gold Hill Drive when his black Honda Prelude swerved off the road and hit Waller about 2 a.m. Saturday.

Waller had a broken leg and possible head trauma, police said, and she was airlifted to Wake Forest Baptist Medical Center.

A hospital spokesperson said Waller was not listed in the hospital's directory Monday morning.

Rojas refused a blood alcohol breathalyzer test on the scene, officers said, but he was taken to Rowan Regional Medical Center and a blood test was taken.

He was then charged with felony hit and run, driving while impaired and driving without an operator's license.

Rojas, of Crown Point Drive, was in jail Monday under a \$12,500 bond.

He was in jail Friday under a \$2,500 bond.

On Thursday, a Salisbury Police officer said authorities expected to charge Salazar with driving left of the center line and a child restraint violation.

A man wearing nothing but a T-shirt and trash bag was arrested by deputies from the Beaufort County Sheriff's Office.

According to a press release from the Sheriff's Office, at 12:03 a.m. on April 8, a caller reported a sex offense at a residence on Gage Lane in Washington. Deputies attempted to locate the suspect, but were unable to until another call reporting a suspicious male in the woods off Highway 264 near the Beaufort County Animal Shelter came in at 10:33 a.m.

Marco Antonio Mendez-Roblero, 20, of Edwards Mobile Home Park in Greenville, was identified as the suspect. He was charged with felony breaking and entering and one count statutory sex offense against a person who is 13, 14, or 15 years old by a defendant who is more than four but less than six years older than the victim. The parent of the victim called to report the crime.

Major Kenneth Watson of the Sheriff's Office explained that the felony breaking and entering charge stemmed from Mendez-Roblero not having the homeowner's authority to enter the home.

"The way the statute is written, any entry with intent to commit a felony, is also a felony breaking and entering. Most of the time you just see (the charge) with a larceny," said Watson.

Mendez-Roblero was held in the Beaufort County Detention Center on a \$20,000 secured bond.

9 suspects held without bond after major drug bust

CHARLOTTE, N.C. — Federal agents have made one of Charlotte's biggest drug busts ever at a warehouse off Tyvola Road.

Prosecutors say the ring of nine suspects had conspired to smuggle more than a ton of marijuana into Charlotte in just the first two weeks of April.

All nine appeared before a federal magistrate Wednesday who ordered them held without bond. Federal agents said Victor Guerra, Paul Ayala, Cesar Garcia, Jose Segiva, Jose Al-Godoy, Carlos Sandoval-Uriel, Rigoberto Pacheco-Carrillo, Ricardo Munoz-Contreras and Jose Zenteno all face felony drug charges for trying to smuggle in and traffic close to a ton of pot in the Charlotte area.

Witnesses who were near the warehouse complex on Griffith Road Tuesday said they smelled marijuana burning and saw agents bringing out marijuana.

"They started bringing out bales and bales of marijuana and they were in wheels -- looked like little tires," said a witness who snapped pictures of the bust on his cellphone.

He said the drugs were hidden in construction equipment that was apparently the cover for the smuggling operation.

A fire truck stood by as agents cut through the metal barrels with blowtorches, just in case the drugs caught fire. Zac Pearson, who works nearby, said he had noticed trucks pulling up to the warehouse but did not know what they were hauling.

"No, I never saw them before. I never met them before. I just saw a truck come in, that was it -- delivering that equipment," Pearson said.

Federal prosecutors say Immigration and Customs Enforcement officers led the investigation. All suspects are due back in court Monday for bond hearings.

Narcotics suspect is 'major supplier'

Following a two-month undercover operation that conclude in late 2011, Lincoln County Sheriff's Office narcotics officers said they placed a "major supplier" of cocaine hydrochloride and marijuana behind bars Monday night.

Rodolfo Lopez Hernandez, 25, of 300 East Sumner Street in Lincolnton, faces multiple drug-related charges.

A department press release noted that undercover buys took place in November, but due to the nature of the case, the Sheriff's Office was unable to release additional details on the arrest or operation.

Hernandez faces five felony counts of maintaining a vehicle/dwelling for a controlled substance along with four felony counts each of trafficking in cocaine and possession with the intent to manufacture, sell and deliver cocaine and one felony count each of sell and deliver marijuana and possession with the intent to manufacture, sell and deliver marijuana.

Hernandez is currently being held in the Harven A. Crouse Detention Center under a \$200,000 secured bond.

The suspect's criminal record in the county, according to the North Carolina Department of Correction website, includes a level four DWI. He was convicted of the misdemeanor charge in February.

Nearly 150 illegal immigrants arrested in Carolinas

CHARLOTTE -- Immigration and Customs Enforcement rounded up nearly 150 illegal immigrants in the Carolinas as part of Operation Cross Check. The six-day operation is being labeled the largest of its kind. In that span, more than 3,100 people were arrested in part of the nationwide sweep.

ICE officials are calling these some of the worst fugitives and immigration violators. Arrests occurred in all 50 states, the District of Columbia, Puerto Rico and three U.S. territories. This is the third round up operation in the past couple of years, yielding the highest number of arrests.

ICE officials say the numbers speak for themselves.

"Of the 3,168 individuals we arrested, 2,834 had criminal convictions," said John Morton, the director of ICE. "Six hundred and ninety eight were immigration fugitives, having ignored an order of deportation. Five hundred and fifty nine were illegal re-entrance who had been deported one or more times from the United States and reentered again in violation of the federal law."

ICE officials arrested 43 illegal immigrants in South Carolina and 106 in North Carolina. The largest numbers were in Mecklenburg, Johnston, Guilford and Buncombe counties.

Because of privacy issues, ICE is not allowed to reveal any of the identities or offenses from those arrested here in the Carolinas.

Man arrested after Walmart parking lot confrontation

ASHEBORO — A Ramseur man was charged after officers said he repeatedly hit another vehicle in the Walmart parking lot on Monday, as well as bumping an Asheboro Police patrol car.

Eusebio Flores-Mendoza, 52, of 4697 Brownlee Road, Ramseur, was charged with assault with a deadly weapon with intent to kill inflicting serious injury, assault on a female and injury to personal property.

According to an Asheboro Police Report, officers responded to the Walmart parking lot at 8:18 p.m. where Flores-Mendoza was driving a 1998 Pontiac passenger car and chasing another vehicle through the lot. According to witnesses, the suspect had hit the 1995 Toyota, which was being driven by Daniel Sexton of Thomasville, multiple times with his own car.

They said he also drove carelessly through the parking lot and at one point blocked Sexton's vehicle in and approached the occupants on foot. He then grabbed a pregnant woman, Mary Wyatt, who was in the back seat and tried to pull her out of the car. She was later transferred by EMS to Randolph Hospital where she was treated and released.

When Officer M. Vann said he approached the suspect's vehicle, Flores-Mendoza neglected to place the car in park and it rolled into the front of his patrol car. Flores-Mendoza told Vann he was only trying to collect rent owed to him by the victims.

Flores-Mendoza was taken to Randolph County Jail and placed under a secured \$10,000 bond. He was also cited with careless and reckless driving and a safe movement violation.

Child rapist will not face charges thanks to I.C.E. policy

Two weeks ago, Juan Carlos Santos-Hernandez was sitting in a Forsyth County jail cell after being charged with three felonies in connection with the molestation of a 10-year-old girl.

A written plea offer prepared by prosecutor Kia Chavious spelled out the likely path for the 21-year-old: Plead guilty and the state will agree to let you be sentenced for one felony instead of three. You might get out in 25 years. Wait much longer or take your chances with a jury, you may die behind bars.

Now that's moot, thanks to an ill-advised policy being followed by the U.S. Immigration and Customs Enforcement Agency. Within a week or two, Santos-Hernandez could be lying on a beach in Acapulco, a free man sipping cervezas in Mexico.

"He very well may get a pass on these charges," Chavious said in court last week. "(ICE) understands our position, but there is no mechanism to stop it. Once the ball is rolling, nothing is going to stop it."

Road map to a loophole

As one might expect, the story of how a person charged with child molestation can get a get-out-of-jail-free card from the federal government involves more than a few twists.

Santos-Hernandez, whose last known job was a cook for a Winston-Salem chain restaurant, was arrested in October on one count of taking indecent liberties with a child. He went to jail and had bond set at \$100,000. He stayed there while investigators continued to look into the allegations.

In early March, a grand jury indicted Santos-Hernandez on two additional felony counts - including the more serious charge of committing sex offense with a child that carries a mandatory 25-to-life sentence.

As is typically the case in crimes involving illegal immigrants, the federal government had issued a "detainer" on Santos-Hernandez. That means the minute he walked out of jail, he was subject to be deported.

What happened next defies common sense.

The scheme was outlined in court documents and in an "order for arrest" motion that Chavious argued Wednesday - a last-ditch legal maneuver that basically says Santos-Hernandez was never formally charged with the new crimes and needs to be brought back.

On March 22, Santos-Hernandez posted bond and left the county jail. (Because Santos-Hernandez technically did not flee custody willingly, his bond likely will not be forfeited.)

Predictably, ICE snatched him up and sent him to a federal detention facility in Georgia. It happened so fast his own lawyer didn't even know he had left the local lockup.

And because he waived his rights, Santos-Hernandez was put on the fast track for deportation.

Goodbye, prison. Hola, Mexico.

"It looks like he's using voluntary deportation as an escape hatch," Superior Court Judge Ron Spivey said to Chavious during the hearing. "Is that your concern?"

"It's something they're all looking into doing," Chavious said. "Post bond and trigger that 48-hour response (from ICE), then waive their rights. They're back home in a week or shortly thereafter."

U.S.: 'So what?'

Not that it should come as a tremendous shock, but the response from the federal government amounted to a huge "So what?"

Heck, the feds wouldn't even acknowledge they had Santos-Hernandez in custody - that information came out in state court last week.

"I'm not sure how long you've covered this stuff," said Temple Black, a regional public-information officer for ICE based in New Orleans, on Tuesday. "Ever heard of the Privacy Act? Send us an email, we'll staff it and see what we can do." Never heard back.

Deep down, state prosecutors know the feds aren't likely to send Santos-Hernandez back. Asking for an order for arrest on the new charges (and a new, bigger bond) essentially amounted to a legal "Hail Mary."

Terrence Hines, Santos-Hernandez' attorney, did what he was supposed to and argued for his client even though he was cooling his heels in Georgia.

"He won't be allowed to return (to the United States) for 10 years," Hines said. "It's not a blank check. He will be a free man in his home country, but he can't come back."

Spivey issued the order for arrest and set a new bond at \$500,000, if he is ever arrested on the additional charges. "I can't think of any logical or rational explanation (for posting the first bond) other than it was done to escape prosecution," Spivey said.

The effect, in reality, is that a red flag got put in the system should Santos-Hernandez be stupid enough to slip back into this country.

That's no consolation. If the charges are true, somewhere in Forsyth County, a 10-year-old girl could carry emotional scars forever. In all likelihood, she and her family will be denied their day in court.

"Generally speaking, the only place appropriate for a child molester to be sent upon conviction would be prison for the rest of his natural life," said District Attorney Jim O'Neill. "And that's only because we're not allowed to execute them "

Seven Charged With Fraudulent Tax Refund Scheme

Conspirators Operated in Gaston, Lincoln and Mecklenburg Counties

CHARLOTTE, N.C. – Four out of seven defendants charged in a scheme to defraud the government by obtaining false and fraudulent income tax refunds were sentenced in U.S. District Court yesterday by Chief U.S. District Judge Robert J. Conrad, Jr., announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina.

The criminal indictment filed in March 2011 charged seven individuals with **one count of conspiracy to defraud the government with respect to false claims, by filing fraudulent tax returns seeking refunds**. The defendants prepared the fraudulent returns using stolen identity information of individuals in Puerto Rico.

Each of the four defendants sentenced today previously pled guilty to one count of false claims conspiracy:

- Dania Ramos, 36, of Lincolnton, pled guilty in July 2011 and was sentenced to 48 months in prison.
- Jose de Jesus, a/k/a Jose Ramos, 29, of Vale, pled guilty in July 2011 and was sentenced to 37 months in prison.
- Xiomara Amparo, 34, of Lincolnton, pled guilty in August 2011 and was sentenced to 18 months in prison.
- Mildred DePena, 49, Lincolnton, pled guilty in August 2011 and was sentenced to 12 months and one day in prison.

Of the three additional defendants charged in the indictment, Nelson Jimenez, 51, of Lincolnton pled guilty in August 2011 and is free on bond while waiting to be sentenced. Arileyda Amparo, 31, of Lincolnton, was a fugitive until she was arrested in October 2011. Arileyda Amparo entered a plea of guilty to one count of false claims conspiracy in January 2012, and is now in local federal custody awaiting sentencing. The last defendant named in the indictment, Johan Vargas, 22, of Hickory, remains a fugitive from justice.

According to the indictment, filed plea agreements and court proceedings:

From January 2010 through February 2011, the defendants participated in a scheme to defraud the U.S. Treasury Department by obtaining false tax refunds. To carry out their fraudulent scheme, the defendants

obtained stolen identity information, including names and Social Security numbers of individuals in Puerto Rico, and prepared fraudulent federal tax returns using that information. The defendants carefully selected addresses within the Western District of North Carolina at locations where multiple mailboxes were clustered, and then caused the Treasury Department to mail the false tax refund checks to these specially chosen addresses. The defendants then used the Internet to check the delivery dates of the fraudulent refund checks, pulled the checks out of the mail at the chosen clustered addresses, and cashed the refund checks at various money services businesses located in North Carolina and elsewhere. The defendants then used the money for their own gain. The defendants sought fraudulent refunds totalling more than \$3 million during 2010 and more than \$2 million from January 2011 up until their arrest in mid-February of 2011.

In sentencing the defendants, Chief Judge Conrad stated with regard to the scheme that the fact that the false claims conspiracy was "hard to detect and easy to do" was a "bad combination" and noted the importance of deterrence in tax cases.

"Schemes that involve filing fraudulent tax refunds using stolen Social Security numbers are very complex and a growing epidemic," said U.S. Attorney Tompkins. "My office is committed to working with our partners to identify tax fraud and go after those who defraud the tax system and obtain fraudulent refunds using the stolen identities of unsuspecting victims."

"Tax refund schemes are especially egregious when identity theft is used to expand the scheme. IRS Criminal Investigation will respond to these schemes using every legal resource at our disposal," said Special Agent in Charge Hammett.

Jose de Jesus will be transferred to the custody of the Federal Bureau of Prisons upon designation of a federal facility. Ramos, DePena, and Xiomara Amparo remain free on bond and will-self report to the Federal Bureau of Prisons at a later date.

The case was investigated by IRS-CI, the USPIS, and the USSS. The prosecution is being handled for the government by Assistant U.S. Attorney Jenny Grus Sugar of the U.S. Attorney's Office in Charlotte.

2 Face Charges After Yadkin County Meth Probe

They will appear in court April 17.

Police said he later registered 0.14 on the Breathalyzer. He was also charged with driving left of center and driving without a license.

A passenger, police identified as the owner of the vehicle, Oscar Anibal Duran Lemus, 38, of Shepard School Road, Zebulon (right) was charged with aiding and abetting driving while impaired for allegedly allowing Montez to drive his vehicle even after he knew he had been drinking.

Montez was released on a \$2,000 bond and Lemus was freed on a \$1,500 bond. Both were given June 12 court dates in Johnston County District Court, according to police reports.

Police crack million dollar theft ring in Charlotte

Police say they've arrested a Charlotte man in connection with a sophisticated theft ring that took more than a million dollars worth of goods from area stores and tried to resell the stolen items on Craigslist.

Police identified **Daniel V. Reyes** as on of the members of the ring. He's been **charged with four counts of possession of stolen property** stemming from cases at several Charlotte-area businesses, including Barefoot Archery on Old Pineville Road and Diver's Supply on Clanton Road.

Reyes was in Mecklenburg jail Thursday on \$85,000 bond, but jail officials have also put an immigration hold on him because they believe he is in the country illegally.

Three months ago, police began investigating a series of thefts that fit a similar pattern. The suspects disabled security alarms after business hours, forced their way in, and removed a range of merchandise – musical instruments, hunting and outdoor equipment, ballistic vests and electronics.

Police learned the property was being sold on Craigslist. They also discovered it was being warehoused at a building on Rosewood Avenue in Kannapolis.

On April 5, police searched the building and recovered "a large quantity of stolen merchandise with an estimated value of one-million dollars," according to a police statement. They also discovered a marijuana growing operation.

Police say they've taken out arrest warrants for two other men they believe were involved in the operation: 23-year-old Ineido Cepero Aldana and 29-year-old Elias Larosa.

NCDMV Impersonator Arrested

RALEIGH - The North Carolina Division of Motor Vehicles' License and Theft Bureau this week announced the arrest in Virginia of a man suspected of impersonating an NCDMV security employee and charging Hispanic victims thousands of dollars for driver licenses.

The man has been identified as Andres Diaz Gonzalez. He is also known as Rafael Hernandez Nunez, "Armondo" and "Cuba." Gonzalez was last seen at the Fuquay-Varina Driver License Office on March 12, where 12 people were victimized.

Inspectors with the NCDMV License and Theft Bureau traced Gonzalez to the Hampton Roads area of Virginia and notified the U.S. Marshal's Office of his whereabouts. Officers from the U.S. Marshal's Joint Task Force along with the Hampton (Va.) Police Department arrested Gonzalez on Monday. He is being held under no bond and is scheduled to appear in court on April 18 in reference to his extradition to North Carolina.

Victims said Gonzalez claimed he could obtain driver licenses for Hispanics who did not otherwise qualify for one. They said he collected \$1,500 for each license and required the victims to assemble a group of at least 10 "customers" before escorting them to the driver license office. Victims said he wore a black shirt or jacket emblazoned with security emblems. While the victims waited for their licenses, Gonzalez would leave by the back door of the office, taking their money with him.

Gonzalez is believed to have committed the same crime at least three other times since June 2011. To date, there are 55 outstanding felony warrants in North Carolina for his arrest. Charges include obtaining property by false pretense and conspiracy to commit false pretense.

Man gets 11 years in shooting death

SALISBURY — A Salisbury man will serve at least 11 years in prison for the shooting death of his girlfriend at the home they shared in 2010.

Denis Omar Funez-Flores, 28, accepted an Alford plea Thursday morning to second-degree murder of Kendy Patricia "Patty" Funez, 25, and was sentenced to a minimum of slightly more than 11 and a half years to a maximum of 15 years.

An Alford plea allows a defendant to maintain his innocence while acknowledging prosecutors have sufficient evidence to obtain a conviction.

The incident occurred Aug. 19 at the Oakhurst Drive mobile home Kendy Funez shared with Funez-Flores. The two were first cousins.

According to police reports and witnesses at the scene, the two argued prior to the shooting.

Rowan County District Attorney Brandy Cook read from law enforcement statements during the short plea hearing, which was held in Superior Court.

When Salisbury Police officers arrived at the murder scene, they saw people outside the home as well as inside, where Funez-Flores was.

Officers repeatedly asked Funez-Flores to sit down, but he kept walking and attempting to touch the victim.

Kendy Funez's body had been moved from the floor to the bed. It was later discovered Funez-Flores moved her.

Investigators found a 20-gauge Mossberg shotgun in a master bedroom closet. They also found an air pistol and some marijuana in the home.

Funez-Flores first told Salisbury Police investigators the two thought they heard someone poking around outside and he took his shotgun as he looked around the house.

The two had been drinking; investigators counted 35 empty Corona beer bottles on the kitchen table.

The defendant said Kendy Funez walked toward him inside the master bedroom as he had the gun pointed. She pushed the gun away from her face and it "just went off."

Kendy Funez was shot in the head with a 20-gauge at close range.

WATAUGA COUNTY, N.C. — Boone Police Department arrested a high school student Wednesday on suspicion that he was recruiting students to participate in a gang-related fight.

Enrique Rivera Alvarez, 17, was charged with soliciting gang activity — a felony, according to the Boone Police Department. He was held at the Watauga Detention Center in lieu of a \$10,000 secured bond and is scheduled to appear in court May 17.

Extra officers were stationed at and around Watauga High School on Wednesday in response to rumors of that possible fight.

Another student, Humberto Ascencio-Estrada, was charged Wednesday with misdemeanor disorderly conduct in an unrelated incident after he got into an altercation with another student, according to police.

"The Boone Police Department is committed to fighting criminal gang activity," stated the news release from the department. "The investigation into this incident continues, and additional charges may be forthcoming."

The ordeal began this week when a group of students notified the school resource officer late Tuesday that they had received threats via text messages, according to police. The person or group of people sending the texts — some of which mentioned gang activity and weapons — threatened to harm the students Wednesday, and the text message recipients were worried that the unknown person or group would come to the school, police said.

CHARLOTTE (AP) — Police say a 17-year old has died and another teenager has been charged after a street racing accident in Charlotte.

Authorities say two cars were racing at around 1:30 a.m. Sunday in East Charlotte. One of the drivers, 18-year-old Javier Juarez-Cruz, lost control of a Ford Expedition and flipped.

Investigators say Jose Angel Juarez-Cruz was standing up with his body outside the SUV's sunroof and was thrown out when it flipped. Police say he was killed on impact. Two others were sent to the hospital.

He had been jailed for speeding and driving without a license just three months ago.

Javier Juarez Cruz was charged with several crimes after he got out of the hospital Sunday: Death by motor vehicle, driving while impaired under the age of 21, no operator's license and reckless driving.

He was in Mecklenburg jail late Sunday under a \$16,500 bond.

Man arrested on cockfighting charges

GREENSBORO — A Greensboro man has been arrested on charges of cockfighting and animal cruelty.

The Guilford County sheriff's office says **Umberto Almazan Rubio** was arrested Wednesday after officers searched his home. Animal control officers seized more than 100 roosters, hens and chicks.

Deputies say they learned Rubio was using his home for cockfighting and to raise roosters to fight. Officers found drugs to make the birds larger and stronger.

Deputies say there were tethers in the ground that can be used to train the birds.

Officers say most of the roosters were kept in poor, cramped conditions.

Rubio is charged with two felony counts of cockfighting, one misdemeanor count of animal cruelty and altering the serial number on a gun.

It was not clear if Rubio has a lawyer.
