## **Winston-Salem child rape suspect arrested in Atlanta**

WINSTON-SALEM, N.C. — A Winston-Salem man suspected of sexually abusing a child was arrested last week in Atlanta, Ga.

Police say **Eduardo Olea Herrera**, 33, of Bethabara Road, was arrested Thursday night on Buford Highway in Atlanta.

The suspect is **charged with five counts of statutory rape and five counts of felony child abuse**.

According to the Winston-Salem Police Department, officers began investigating allegations that Herrera was sexually abusing a juvenile on Jan. 3.

Investigators learned that Herrera had allegedly abused the victim repeatedly over the course of several years, police said.

Police say Herrera abruptly left his home on Thursday morning while evidence against him was being gathered.

Warrants for the suspect's arrest were then issued, after which he was taken into custody by ICE agents and Atlanta police officers. Police said he was on a bus headed for Mexico.

Herrera is currently being held in the DeKalb County Jail while detectives work to extradite him back to Forsyth County.

A Winston-Salem man was charged Tuesday with **four counts of taking indecent liberties with a child**, authorities said Wednesday.

**Reynaldo Jesus Arteaga Jr.**, 30, who lives in the 2800 block of Thomasville Road, is accused of abusing a girl over several months, city police said.

Arteaga was being held Wednesday in the Forsyth County Jail with bond set at \$350,000. He is scheduled to appear in court Thursday.

## Apex police charge man with copying child porn

APEX — Police arrested a 25-year-old man Wednesday and **charged him with nine counts of second-degree sexual exploitation of a minor** for having copied what they said were pictures of children in sexual situations.

**Mohd Tashfiqur Rahim** of 1412 Park Summit Blvd. was arrested at town police headquarters, according to a report.

Arrest warrants alleged that between March 26 and April 14, Rahim had “duplicate” images.

Unlike many exploitation cases that involve tracking suspects through Internet connections, the warrants do not say the pictures were kept on a computer.

Rahim was held in lieu of \$125,000 bail for a court appearance.

A Smithfield man was arrested by police on child abuse charges this week. **Luis Antonio Mendez, 41, (aka Luis Antonio Ruiz)** of Michael Lane was arrested after his 13 year-old daughter allegedly showed up at Smithfield Middle School with bruises on her legs.

School administrators contacted police, who in turn questioned the father. Mendez allegedly admitted to beating the child with a belt, according to Smithfield Police Lt. Keith Powell.

Mendez was **charged with misdemeanor child abuse**. He was released on a \$500 bond pending a May 15 court date.

## **Suspect Accused Of Sexually Assaulting Unconscious Woman**

Authorities have **arrested a suspect who allegedly sexually assaulting a woman while she was unconscious.**

**David Escobar Herrera**, 31, of Woodland Church Road, Dudley was arrested Thursday by the Wayne County Sheriff's Office.

The allegedly incident happened April 14. That's when deputies responded to a 911 call about a disturbance at Herrera's home. When deputies arrived they reportedly found the victim nude and unconscious on the bathroom floor. She was taken to Wayne Memorial Hospital for treatment. An investigation by officers found the suspect had allegedly performed a sex act on the victim while she was unconscious.

Herrera is charged with second-degree forcible sexual assault. He was confined in the Wayne County Jail under a \$100,000 bond.

## **4 charged with kidnapping in Hickory**

HICKORY, N.C. — There is new information about a kidnapping in Hickory where a man was abducted from the parking lot of a Lowe's home improvement store.

The lead investigator of the case said the suspects planned the kidnapping before leaving their homes in Chicago.

**The four suspects were charged with felony conspiracy and kidnapping. They were identified as Jorge Alonzo Rentas, 21, of Chicago (also charged with robbery with a dangerous weapon); Alejandro Zambrano, 23, of Orlando Park, Ill. (also charged with robbery with a dangerous weapon); Gema Yadaria Zambrano, 23, of Chicago; and Orlando Zambrano, 19, of Chicago.**

**Police said three of the four people arrested in the case are in the country illegally.**

One suspect after another appeared before a judge Wednesday in Newton, charged with kidnapping Alfonso Moreno from a Lowe's parking lot in Hickory.

His girlfriend, who asked we not show her face, said Moreno had gone to buy curtains for their home.

About an hour after leaving she started getting phone calls demanding a \$200,000 ransom for his safe return.

"Twelve o'clock was what they said was it or they would kill him. This is bad, this is bad. They want us to come through with some money now or we are not going to make it," she said.

"We believe he was specifically targeted because he had access to money and that he could get money for his release," said Capt. Reed Baer with Hickory police.

According to a search warrant, police traced the phone calls to a mobile home in southeast Hickory where they made the arrest after finding Moreno restrained. Inside they recovered several guns, rope, and a roll of duct tape. Moreno's girlfriend has a message for police.

"I am just very, very thankful," she said.

Police said they have already been in contact with ICE about the suspect's immigration status.

All four of them are scheduled to be back in court on May 15 for a probable cause hearing.

Each is being held under \$500,000 bond, Hickory police say.

Bond for Estrada-Avina was set at \$250,000.

BRUNSWICK COUNTY, NC (WWAY) -- A Leland man is in jail without bond accused of breaking into a home and raping a pregnant woman.

The Brunswick County Sheriff's Office says **Joel Fernandez**, 28 of Shasta Lane in Leland, broke into the home in Leland between 10 and 11 p.m. Sunday. They say once inside, Fernandez allegedly raped a woman who was three months pregnant.

**Fernandez is charged with first-degree burglary, injury to real property, assault by strangulation, battery of an unborn child, second degree rape and assault on a female.**

## Man Wanted for Attempted Murder in Indiana Arrested in Four Oaks

A man wanted on attempted murder charges in Indiana has been arrested. **Prospero Hernandez, 51, who also goes by the name of Tomas Gonzales,** was **arrested by Smithfield Police Saturday morning at 2:16am for driving under the influence on Highway 301 South.**

**While being booked into the Johnston County Jail, Hernandez, who had given police his fictitious name, was fingerprinted. His fingerprints matched a wanted persons warrant from Bartholomew County, Indiana.**

Hernandez had most recently been living on Highway 301 in Four Oaks and using his alias.

He was served with the attempted murder warrant by the Johnston County Sheriff's Office and is being held in the Johnston County Jail without bail, awaiting extradition to Indiana.

According to the Bartholomew County Sheriff's Office, Hernandez allegedly stabbed an individual in the Hill View Trailer Park in 2007.

It remains unclear how long Hernandez had been living in the Four Oaks area.

## Illegal Alien Charged with Murder

A man who authorities say is in the county illegally has been arrested in the shooting death of a Hamlet man.

**Uribe Morales Avalos,** of Mexico, is accused of killing 26-year-old David Delon Hernandez, police said.

**Avalos is also charged with shooting Miquel Valencia Sanches of Laurinburg.** Sanches, who was shot in the neck, has been hospitalized.

Scotland County Sheriff Shep Jones said the shooting occurred as the men were working in a field on Joe's Creek Road, off U.S. 74 at about 7:30 p.m. Tuesday.

"It appears that the men were collecting pine straw and drinking and got into an argument," Jones said. "We believe he (Avalos) went to his truck and retrieved a rifle and shot the other two men."

Hernandez, of 178 Maynor Road in Hamlet, was shot in the upper body, according to Jones. He died at the scene.

Jones said that Sanches of 20780 Harrison Road, Laurinburg, was struck in the neck. Sanches was taken to Scotland Memorial and later transferred to another facility. His injuries are not believed to be life threatening.

Jones said Avalos used a 22-caliber rifle to shoot both men. He was taken into custody without incident, Jones said.

Avalos, who authorities estimate is in his 30s, has also been **charged with first-degree murder, assault with a deadly weapon and intent to kill and inflict serious injury.** He is being held in the Scotland County jail without bond. His first court appearance was Wednesday. Authorities do not have an address for Avalos.

Jones said that translators have been brought in to assist with interviewing Avalos, witnesses and the surviving victim.

## **Sampson deputies searching for homicide suspect**

Deputies responding to 33 Garcie Family Lane about 4:30 p.m. found Margarito Perez-Lopes. CPR was performed by bystanders, but Perez-Lopez died on the scene.

Deputies said Perez-Lopez was involved in a verbal argument with another man when gunfire erupted. The suspect fled the scene in a small brown passenger van, heading toward Duplin County.

Witnesses identified the suspect as **Noe Garcia Luna**, 45. He is described as a white male of Hispanic decent, about 5 feet 6 inches tall, weighing about 200 pounds, deputies said.

A warrant for Luna's arrest was issued Sunday.

## **15-year-old can be charged as adult in Wake double slaying**

RALEIGH, N.C. — A 15-year-old boy charged four months ago in the shooting deaths of a married couple in their Wake County home can be tried as an adult, a District Court judge ruled.

A witness testified during a probable cause hearing Tuesday that Jose Samuel Flores Mendoza and his wife, Maria Saravia Mendoza, both 34, were unintentional victims in a dispute between two rival gangs and that the target had lived in their house, at 708 Colonial Drive near Garner, for about six months in 2011 prior to the Mendozas moving there.

The couple was found dead in their home shortly after 12:30 a.m. on Jan. 5. Their 3-year-old son, Jacob, was found unharmed.

The teen, **a juvenile whose name has not been released, and his 16-year-old uncle, Issrael Vasquez**, were arrested less than three weeks after the shootings.

**Each is charged with two counts of murder, felony conspiracy, first-degree burglary and possession of stolen property. Vasquez faces an additional charge of possessing a firearm with an obliterated serial number.**

Tuesday's witness testified that he was with the suspects on the morning of the shootings but that he waited outside in a car while they – both armed and wearing hair nets, masks and gloves – kicked in the door and shot the couple.

One had a handgun and the other an AK-47, the witness said. Afterward, they returned to the car, where the teen, smiling, mentioned seeing a child inside.

"We left him alone," the witness recalled the teen saying. "He will be traumatized."

Scott Barefoot, an investigator with the Wake County Sheriff's Office, testified that Maria Mendoza was killed first and that a small child came running out of another room and witnessed Jose Mendoza being shot.

The home, Barefoot said, "was all shot up."

According to a search warrant, investigators found 11 shell casings from a .45 caliber handgun and 29 from a 7.62 mm rifle.

Also testifying Tuesday was Maria Mendoza's brother, Carlos Saravia.

He said that he last saw his sister and brother-in-law on Jan. 4 when he went to pick up the couple's 12-year-old son, Jorge. The boy wasn't home at the time at the time of the killings, Saravia said, because he had spent the night with him.

Saravia said after the hearing that he and his brother are now caring for the Jorge and Jacob and that the case has been very difficult for the family.

He added that they are anxious to get a trial date.

It's still unclear as to when that will be. Both suspects have not yet been indicted.

## **Florida double murder suspect caught in Nash County**

ROCKY MOUNT, N.C. -- A Florida man **wanted on two counts of first-degree murder** has been captured in North Carolina.

**Raynaldo Figueroa-Sanabria** was apprehended by the North Carolina Highway Patrol about 1 a.m. Saturday while traveling north on Interstate 95 near Rocky Mount.

Figueroa-Sanabria is wanted the deaths of John Joseph Travlos and Germana Morin.

The elderly couple were found dead Friday aboard a houseboat in St. Petersburg, Fla. Officials said the 40-year-old Figueroa-Sanabria was taken into custody after a state trooper recognized his gold 2004 Ford Taurus. He is believed to have been headed to New York.

Figueroa-Sanabria was **also arrested on an outstanding warrant for trafficking cocaine.**

He is being held in the Nash County jail, where Florida detectives are expected to question him pending a request for extradition.

## Sampson County man sought on murder charge

CLINTON - A Sampson County man is **being sought in the fatal shooting** of a Magnolia resident Saturday, authorities said.

A warrant for murder has been issued for **Noe Garcia Luna**, 45, of Mertina Road in Magnolia, according to a release from the Sampson County Sheriff's Office.

Deputies were called to a home on Garcia Family Lane about 4:30 p.m. Saturday, where the shooting was reported to have happened, the release said.

When they arrived, they found the victim, 33-year-old **Margarito Perez-Lopez**.

Bystanders were attempting to revive Perez-Lopez, but he was pronounced dead at the scene, the release said.

Investigators said Perez-Lopez was arguing with Luna, who also goes by the name of Noe or Noel Garcia, when he was shot, the release said.

Luna is about 5 feet 6 inches tall and weighs between 190 and 200 pounds. He has brown hair and brown eyes.

Luna was last seen driving a tan or beige sport utility vehicle, possibly a Jeep Cherokee, heading toward Duplin County, the release said.

## Latino gang announces arrival, marks turf

**Sureño 13 is in Kinston**, and the California-based gang wants you to know it.

Seemingly overnight, gang tags appeared at Emma Webb Park, on brick walls on Independence and North Queen Streets and on the walls of Grainger Stadium.

**Large, spray-painted tags included terms common to law enforcement, like “Sureño 13,” “Sureños Trece,” “SUR 13” and the large “Brown Pride” phrase written on the side of the historic baseball stadium.**

Sgt. Dennis Taylor, who leads the Kinston Department of Public Safety's gang unit, said officers were aware of Sureño 13 activity in southern Lenoir County, around Pink Hill, but not within the city.

“Right now we have found out of a couple moving around in the city limits, surrounding the area that has been tagged,” Taylor said. “Right now we're just getting information of all this tagging going on in the city.”

The gang emerged from California prisons in 1968 as a result of warring between Latino Southern Californians — tied to the Mexican Mafia, or La Eme — and Latino Northern Californians — tied to Nuestra Familia and known, naturally, as Norteños. Sureño means southern and Norteño means northern in Spanish.

The gang isn't so much a monolith, but an umbrella criminal organization meant to primarily offer protection and project force in prison, according to information from the Rocky Mountain Information Network, a regional

organization for law enforcement. The many different Sorteño gangs in Southern California are known for routinely warring with each other.

Different law enforcement studies have shown East Coast franchises of the gang tend to be more independent, but Taylor said they still get orders from a coordinated point.

“Some do, but they still have a shot-caller,” Taylor said. “Someone is actually giving them orders to go out and do criminal activities, whether it’s vandalizing a building and doing their signs, which shows ownership of that turf around it.

“Not that they own anything, because they don’t.”

A presentation by the N.C. Gang Investigators Association showed Sureño 13 as one of the top five Latino gangs in North Carolina, and one of the top five overall. They’re known for independently selling drugs bought from Mexican drug suppliers, and also much more.

“Their basic operation is a host of criminal activity, from drugs, weapons, human trafficking, murder,” Taylor said.

He later added that the tags, while marking territory, are also meant to raise the gang’s profile.

“Maybe they haven’t had it, because we have all the other gang activity going around, and maybe they want to step theirs up,” Taylor said. “You know, it’s all about being seen and heard.”

Victor Alvarez, 19, and a juvenile were arrested for the Emma Webb tags, which came from a tip about a vandalized car.

“On May 9, we were called (and told) that someone keyed someone’s car and tagged it,” KDPS spokesman Woody Spencer said. “The officer saw a couple of people walking across the park at Emma Webb, and they ran into a residence at 205 East Highland.

“When they made contact, one suspect, who was a juvenile, had spray paint on their hand. And then an older person who was with that juvenile admitted to spray-painting the vehicle.”

Alvarez resides, or did reside, in Sanford. While he doesn’t have a public prison record, he is wanted in court in three counties. In Lenoir County, he’s charged with injury to real property and injury to personal property.

In Lee County, Alvarez is up for misdemeanor larceny, possession of stolen goods and second-degree trespassing. And over in Wayne County, he’s charged with speeding, reckless driving and having no license.

KDPS hasn’t linked the other tagging incidents in town to Alvarez or the juvenile.

Alvarez was booked in the Lenoir County Jail on \$750 bond and made bail Friday.

## **Suspect Identified in deadly Greensboro hit-and-run**

GREENSBORO, N.C. — Authorities have identified a suspect wanted in connection with a Greensboro hit-and-run that resulted in the death of a moped rider.

High Patrol spokesman Greg Ingram says 25-year-old **Sergio Gomez Espindola** will face charges including **felony hit-and-run causing death, careless and reckless driving, driving while license revoked and improper passing.**

Trooper Ingram says detectives believe Espindola may have left the Greensboro area.

The suspect could have boarded a bus and may be bound for Houston, Texas, Ingram said.

Ingram says Espindola did not own the red Dodge pickup truck he was allegedly driving in the collision, but the suspect had borrowed it from his father-in-law.

The accident claimed the life of 64-year-old Timothy Minor, who was riding a moped on Liberty Road around 6 p.m. Saturday when he was struck by the truck. Troopers say the truck was passing another vehicle illegally when the collision occurred.

The suspect vehicle was found Tuesday at a home at 3004 Mornstar Place, Ingram said.

Espindola's brother told FOX8 they are sorry to Minor's family for everything they've gone through. Troopers say the family willingly turned the truck over to investigators Tuesday.

On Monday, family members pleaded that whoever was responsible for the accident would turn themselves in.

"You just run over him and leave him like a dead animal in the road? I just can't understand that," Minor's wife, Eva Smith, said.

The Highway Patrol extended thanks to FOX8 and other local media that originally published the story. After the story aired, troopers say they received many tips that helped them find the suspect vehicle.

"The citizens of North Carolina have cared enough to contact us in reference to tips which in turn led to locating a vehicle," explained Ingram.

Minor's wife, Eva Smith, tells FOX8 these developments in the investigation are helping them heal.

"If they found the truck, they're gonna find the driver. He's gonna have to come back, and he's gonna have to face a lot of people," she said.

## **Last 24 Hours Yields 29 Arrests in Human Smuggling**

(Phoenix, AZ) Maricopa County Sheriff's Office Detectives in the Human Smuggling Unit (HSU), together with Sheriff's Office Patrol Deputies and Lake Patrol Deputies, captured 14 suspects and booked a majority of them into jail on human smuggling charges on April 17, 2013, Sheriff Joe Arpaio announced today.

All fourteen were border violators who had entered the country near the Tucson sector of the border.

HSU detectives were conducting an investigation of a Chevy Venture in northern Maricopa County at around 7:45 p.m. When the SUV came to a stop on the roadside, four suspects fled on foot into the desert, while twelve other suspects were apprehended at the scene.

Detectives spotted a Nissan Maxima at the same time that was acting as a “heat vehicle” and subsequently took the vehicle into evidence after its occupants abandoned the vehicle and fled. Two of the fleeing suspects from the main vehicle were taken into custody after a search of the area.

It was learned that the suspects had paid up to \$7,000 to be illegally transported in the United States and **were destined for Maryland, North Carolina, Georgia, Florida, Virginia and Massachusetts**. Six suspects claimed to be Guatemalan nationals, three claimed to be Honduran nationals and two claimed to be Mexican nationals.

During a separate HSU investigation in Gila Bend, six other suspects were apprehended and the greater part of this group was booked into jail on human smuggling charges. In the past 24 hours, 29 arrests have been recorded by the Human Smuggling Unit.

Sheriff Arpaio commented: “We enforce all laws and will continue to crack down on criminal violations related to the border, regardless of politics, threats and intimidations that are routinely tossed in our way.”

## **Human Smuggling Unit Investigation Leads to Arrests of 15 Heading to Tennessee and North Carolina**

(Phoenix, AZ) An investigation by HSU Detectives in the Maricopa County Sheriff’s Office has led to the arrest of 15 border violators from Guatemala and Mexico after the Dodge Caravan they were traveling in was detained on May 22, 2013, Sheriff Joe Arpaio announced today.

The Human Smuggling Unit’s investigation revealed that the suspects had paid up to \$4,500 to be illegally transported into the United States and had crossed into Arizona near Alter and Mexicali before being located in Northern Maricopa County.

**It was learned that the suspects were heading for Tennessee and North Carolina. The Maricopa County Sheriff’s Office has now made 93 human smuggling arrests in the past six weeks.**

“These illegal human smuggling syndicates are using Arizona as a superhighway to carry their paying clients to all parts of the country,” said Sheriff Arpaio. “We have been very successful in stopping them as evidenced with the number of arrests we have been making.”

A total of seven suspects were booked into the 4 th Avenue Jail on class 4 felony charges related to human smuggling.

The remaining eight suspects, including two unaccompanied juveniles from Guatemala, were turned over to Immigration and Custom Enforcement Agents.

## **Raleigh man charged with making fake IDs**

According to a search warrant, they seized a Dell laptop with software to produce fraudulent state and federal IDs, a data storage device with hundreds of fraudulent records, card stock, a printer and four fake IDs.

Salamanca was being held Friday in the Wake County jail under a \$10,000 bond.

## **Man who lived under alias faces multiple charges**

**A man who was living in Elkin under an alias while serving as a volunteer youth baseball coach is now in the Wilkes County Jail.**

**Nigel Allen Garcia**, 34, was arrested Tuesday afternoon at his home by Wilkes County Sheriff's deputies and U.S. Marshals. He was **charged with failure to register as a sex offender, weapons violations and failure to appear charges stemming from Santa Clara, Calif.**

According to Major David Carson of the Wilkes County Sheriff's Office, U.S. Marshals alerted his department of a fugitive warrant calling for Garcia's arrest. Two marshals and four deputies served the warrant at Garcia's residence at 226 Pleasant Hill Drive. Police found 10 guns in his possession, though Carson said Garcia was detained without serious incident.

Garcia's 14-year-old daughter was also located and has since been placed into protective custody with social services. Garcia was transported to the Wilkes County Jail and was scheduled to appear in court Wednesday, but that appearance was continued until June 5. He is expected to eventually be extradited to California.

Carson said Garcia had been living in the part of Elkin that falls into Wilkes County for about two years. He had assumed the alias of "David Quiroga" and was working as a mechanic at Cedarbrook Country Club, according to police.

Elkin Recreation and Parks Department released a statement Wednesday through the Elkin Police Department.

**It stated that both organizations completes background checks of all volunteers and staff and the review of Garcia was based on his alias, and therefore no criminal history was discovered.**

According to Adam McComb, director of Elkin Parks and Recreation, the organization runs about 20 different sports programs throughout the year. He said the size of the programs vary, with as many as 150 children participating in popular team sports such as basketball.

“We try to do as much as we can without infringing on a person’s right to privacy and security,” McComb said of the vetting process for volunteers to assist with the program. “We take our volunteers seriously as far as their qualifications. In general, we want good volunteers. And, as with any agency, a lot of times whenever we get a good volunteer we tend to keep them for a very long time.

“But when it comes to situations as this, things that are hidden are very difficult to detect. With this situation, we did what we normally do. And now we’re going to review our policies with volunteers and see what we can do about the screening process in the future.”

## **FBI busts Mexican drug ring in Concord**

CONCORD, N.C. – Four people are scheduled to appear in Cabarrus County court Wednesday on charges stemming from an FBI probe into an international drug trafficking ring that allegedly shipped more than two tons of marijuana to storage warehouses in Concord.

**Five people are accused of moving more than 4,000 pounds of marijuana from Mexico to Concord** in April, according to search warrants now sealed by a state judge.

One April 5, authorities arrested **Pamela Demae Alegria, Cesar Andres Linares, Sergio Dejesus Linares, Javier Nava and Ana Kristina Ramos**, as part of an ongoing investigation involving the FBI and the Cabarrus County Sheriff’s Office.

**All five suspects were charged with trafficking in marijuana, felony possession of marijuana and possession with intent to sell or deliver marijuana.**

They were placed in the Cabarrus County Jail under \$1 million bonds after authorities say they found almost 4,000 pounds of marijuana between two storage locations in Concord.

The arrests were part of a months-long FBI investigation into a suspected Mexican drug ring that allegedly used a furniture business to hide shipments of tons of marijuana into the United States.

The FBI believes an unnamed man associated with Mexico-based furniture company Woodworld was a leader in the trafficking scheme, according to the search warrants.

Traffickers allegedly hid tons of marijuana in furniture, compressing the marijuana to about one half inch thick and hiding it between pieces of wood that made the items look like shelves.

The drugs were then transported via semi-trucks to warehouses and unpacked.

In November, an informant told the FBI that a shipment of more than 4,000 pounds of marijuana would be heading to Concord in the next 10 days and that it would be in a truck from Woodworld.

Authorities allege that the company moved Cesar Linares and Javier Nava to a house at 435 Central Drive NW, Concord, to await orders from the unnamed leader, according to the warrants. It isn’t clear how long they have been in Concord.

The FBI began investigating Linares in November 2012. In January, Linares rented a storage warehouse at 2054 Wilshire Court, Concord, and told the management company that he was renting the warehouse for a business that deals with furniture.

Authorities searched the warehouse a few days later and found traces of marijuana, but the warehouse was empty, according to the warrants.

Linares tried to rent the same warehouse again, but an employee told him the property was unavailable. The next day, Linares rented a large unit at a self-service storage facility at 593 Wilshire Ave., Concord. He told the manager he needed a unit tall enough to allow entry for a tractor-trailer and large enough to hold 20 pallets of material.

On April 1, the FBI says seven Hispanic adults entered the storage unit and unloaded a tractor-trailer, according to the warrants. They unloaded numerous 4-by-1-foot white boxes – consistent with the size of packaging for shelves.

After more than a day of no activity at the storage facility, investigators believed the suspects were looking for a secure warehouse to unpack the marijuana. An employee of the management company told the FBI someone called and inquired again about the unit on Wilshire Court and immediately hung up when the employee said it was unavailable.

The number matched the area code for McAllen, Texas, where Alegria, Sergio Linares and Ramos list addresses.

McAllen sits on the U.S.-Mexico border and has been an operating site for Mexican drug cartels, according to media reports. It is unclear if the Woodworld drug trafficking ring was associated with any cartel activity. As the suspects continued to look for another site, an Albemarle-based company that was working with the FBI told Linares they had a secure storage unit available at 563 Webb Road, Concord.

Linares and Javier, along with a teenage Hispanic female, toured the property, and Linares signed a six-month lease agreement.

On April 5, authorities arrested the five listed suspects at the Webb Road warehouse. They found four boxes containing 260 bags of suspected marijuana wrapped in plastic and 383 boxes of ironing boards and suspected marijuana.

In all, investigators found at least 4,011 pounds of marijuana between the Webb Road and Wilshire Avenue storage facilities.

Alegria, Cesar and Sergio Linares, and Ramos are scheduled to appear in Cabarrus County Court on Wednesday.

The federal investigation is ongoing.

## **Bizarre details now released in major drug conviction**

SALISBURY - On Friday, a federal court jury in Charlotte convicted **Jorge Molina-Sanchez**, 24, of Mexico, of **conspiring to distribute cocaine and heroin throughout North Carolina** and related charges, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina.

The jury returned the guilty verdict following a three-day trial which ended late Friday afternoon.

U.S. Attorney Tompkins is joined in making the announcement by Brock D. Nicholson, Special Agent in Charge of U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI) in Georgia and the Carolinas, and Sheriff Kevin L. Auten of Rowan County Sheriff's Office (RCSO).

A federal criminal indictment filed in October 2012 charged Molina-Sanchez with **conspiracy to distribute and to possess with intent to distribute at least five kilograms of cocaine and at least one kilogram of heroin, conspiracy to launder proceeds of drug trafficking, possession with intent to distribute cocaine, and possession of a firearm in furtherance of drug trafficking. He was found guilty of all charges.**

According to filed documents, evidence presented at trial and witness testimony:

From in or about 2004 through 2011, Molina-Sanchez and his co-conspirators obtained hundreds of kilograms of cocaine from a supplier in California. The defendant and his co-conspirators transported the cocaine and redistributed it to other traffickers, who sold the cocaine throughout North Carolina. The street value of the cocaine was in excess of \$30,000,000.

To avoid detection, Molina-Sanchez and his co-conspirators transported the cocaine and the drug proceeds hidden in compartments in vehicles. On one occasion, in March 2011, law enforcement found tens of thousands of dollars hidden in the air filter of a vehicle and in a void in the trunk of a car. In July 2011, law enforcement officers discovered and seized from a vehicle three kilograms of cocaine, a kilogram of heroin, and \$138,460 in cash.

Also in July 2011 while executing a search warrant, law enforcement discovered in Molina-Sanchez's house a hand-drawn map of the location where the defendant's sister had been stopped in Utah with eleven kilograms of cocaine in February 2011. Additional trial evidence included telephone conversations in September 2011, during which Molina-Sanchez asked a former co-conspirator to go to Las Vegas to inspect a vehicle and to transport cocaine back to North Carolina.

When officers arrested Molina-Sanchez in October 2012, he was in possession of almost three ounces of cocaine, two handguns, and more than 100 rounds of ammunition.

Molina-Sanchez has been in local federal custody since he was arrested in October 2012 and will remain in custody until his sentencing date, which has not yet been set.

Molina-Sanchez faces a statutory mandatory minimum sentence of 15 years to life in prison, as well as a fine of up to \$10,000,000, and at least five years of supervised release upon his release from prison. Federal sentences are served without the possibility of parole.

The case was investigated by HSI in Charlotte and RCSO, assisted by the Charlotte-Mecklenburg Police Department and its crime laboratory, the Iredell County Sheriff's Office and its crime laboratory, and the North Carolina State Bureau of Investigation.

**DEA catches man accused in North Carolina pot smuggling attempt**

MISSION — Drug Enforcement Administration agents arrested Tuesday a man accused of trying to move **more than 1,000 pounds of marijuana to North Carolina**.

DEA agents used an informant to negotiate a \$145,000 fee with **Alex Gonzalez** to transport 1,000 pounds of marijuana to North Carolina, a criminal complaint states.

Gonzalez later delivered the drug load and \$5,000 to cover moving expenses outside The Home Depot, 120 S. Shary Road, where he promised to pay \$50,000 when the drugs arrived, the complaint states. The rest of the money would be delivered afterward.

Agents arrested Gonzalez on Tuesday after he failed to pay the delivery fee. He was formally charged with two counts of drug conspiracy on Wednesday in federal court.

### **3 arrested in home-invasion robbery, assault**

Investigators said two women and a man broke in through a window of the victim's apartment in the 100 block of N. Park Drive and demanded money and drugs about 8:47 p.m. Saturday.

Police said the victim was struck in the head and face with a blunt object during the robbery.

The robbers took the man's wallet, credit cards, iPhone and an undisclosed amount of cash, police said.

Police said they found one of the robbers inside the apartment. Two other suspects were arrested nearby.

Investigators identified the suspects as Bryant Dalrymple, 30, **Jessica Lopez**, 25, and **Heather Valdez**, 27.

**All three were charged with conspiracy to commit robbery, robbery, assault with a deadly weapon inflicting serious injury with intent to kill, first-degree burglary and possession of stolen property.**

The victim was taken to Moses Cone Hospital and treated for injuries that were not considered to be life threatening.

### **Illegal Immigrants Try To Cash In On Tax Refund Fraud**

RALEIGH — When a woman named Veronica tried to cash a federal income tax refund check for \$8,113 April 5 at a Sampson County check-cashing business, instead of a handful of cash she was greeted by members of the Sampson County sheriff's office who suspected that her tax refund was the result of a fraudulent tax return.

Deputies were acting on a tip that the IRS had issued the check to Veronica, who had used a fictitious identity and reported fictitious earnings on her individual income tax return. Carolina Journal independently confirmed that her refund claim was fraudulent.

They detained Veronica, seized the check, which had been issued March 22, and made a copy of the tax return and a driver's license from Honduras that she used at the check cashing business to establish her identity.

The same day, deputies discovered that four men were attempting a similar scheme, cashing IRS refund checks using phony identities. Altogether, deputies intercepted five IRS checks totaling \$34,380. Veronica and the four men had documents showing them to be from Honduras.

The deputies determined the suspects used forged identification cards. All five admitted they were in the country illegally. Some had been deported more than once. The deputies concluded also that the individuals had not engaged in identity theft but had instead created identities by making up names and tax identification numbers.

Sheriff Jimmy Thornton told CJ he was happy his officers were able to stop some checks from being cashed, but said he has no idea what the magnitude of the problem is in Sampson County, let alone North Carolina.

**The sheriff's office said it had no authority to arrest the five, who were not accused of breaking any local laws. They were released and the confiscated checks and other documents were turned over to IRS investigators. Officials said they consider this an open investigation, ongoing in cooperation with the IRS. Any charges or prosecution likely would be the responsibility of the federal government.**

Thornton allowed CJ to examine copies of some of the items seized. Upon request, CJ agreed to use only the first names of the refund recipients for this story, even though the names likely are fictitious.

Veronica's documents included one from the IRS appearing to assign her an Individual Taxpayer Identification Number, which the IRS uses to track taxes that are due to people who do not have Social Security numbers. She also had a Form W-2 Wage and Tax Statement issued by a New York-based employer that does business in North Carolina and several other states.

The W-2 stated in 2012 she earned \$25,180 in income and had \$5,103 in federal income tax withheld. The ITIN on the W-2 (which she apparently filed with her tax return) was different from the one the IRS had given her, and also different from the one she used on her tax return.

CJ contacted the New York employer to ask if Veronica had worked at the company. A human resources representative said she had not. The W-2 form was a fake, the representative said, so her claim of a refund due from the IRS was a fraud.

On her tax return, Veronica claimed to have three children younger than 17. She listed an ITIN for each. She listed itemized deductions of \$8,400 and claimed the allowed \$3,650 income exemption for herself and each child, leaving her with a taxable income of \$9,450. She listed her tax due as \$948. Under federal income tax withheld, she erroneously listed \$6,051 — the sum of the \$5,103 claimed in withholding and the \$948 tax due. She then claimed an additional child tax credit of \$2,052. Adding those numbers, she claimed a refund due of \$8,103, which is what the IRS sent her.

The others

The four men produced identification claiming they were from Honduras. On Eugenio's tax return, he claimed earnings of \$31,498, withholdings of \$4,378, and \$156 tax due. He received a refund from the IRS of \$6,315,

mailed to an address in Sampson County. He claimed three exemptions on the first page of the return, for himself and two nieces, but on the second page he entered four exemptions.

José's tax return claimed earnings of \$27,691, withholdings of \$4,431, and tax due of \$387. The IRS issued a \$7,053 check March 29 and mailed it to an address in Duplin County.

Carlos claimed earnings of \$24,869, \$4,378 in withholdings, and exemptions for three children. His tax due was \$156 and he received a refund check from the IRS dated March 22 for \$6,671. It was mailed to an address in Clinton.

Ramon's tax return was identical to the one filed by Carlos, except he said he was owed a different refund. On March 15, the IRS mailed a \$6,238 check to an address in Clinton.

None of the returns was filed electronically. Instead, all five returns stated they had been completed by the same Sampson County tax preparer. When CJ phoned the preparer, a woman speaking Spanish answered the call. She then shifted to broken English and indicated the tax preparation business no longer operated. The sheriff's office had told CJ that it received a similar answer when a detective called the number.

### Tax fraud rampant

CJ has reported on what federal officials call Stolen Identity Refund Fraud on several occasions. (Read the earlier stories here.) Officials say it's the "No. 1 tax scam of 2013," with more than \$5.2 billion in losses to U.S. taxpayers reported in tax year 2010.

Yet, as CJ's reporting indicates, some if not much of this refund fraud has slipped past the IRS and state revenue agencies. And because tax officials say they're under pressure to issue refunds quickly to satisfy tax filers, those efforts preclude a thorough examination of tax returns to prevent fraudulent refund checks from being issued. Scam artists can take advantage of these gaps in detection and enforcement.

### **3 charged with multiple financial crimes in Mebane**

**The men were each charged with five counts identity theft, four counts conspiring to obtain property by false pretense, four counts unlawful obtaining credit card, four counts financial card forgery, three counts attempt to obtain property by false pretense, and one count obtain property by false pretense.**

Warrants state Stephenson, Prado, and Perdomo obtained cigarettes from the Dollar General at 107 E. Clay Street, the Walgreens at 801 Mebane Oaks Road, the Lowes Foods at 1020 Mebane Oaks Road, and the Quality Mart #2 convenience store at 1126 Mebane Oaks Road in Mebane.

Each man is being held at the Alamance County jail under a \$250,000 bond. Stephenson, Prado, and Perdomo will make first appearances Wednesday afternoon.

## **Police chase started when man jumped from window**

A man jumped from a third-floor motel window and fled across Interstate 40/85 on Thursday morning before being apprehended by Burlington police.

It was chase that began with police being called to Country Inn & Suites at 3211 Wilson Road at 9:07 a.m. when employees became suspicious of occupants of a room.

“Multiple things jumped off from there,” said Capt. Eric Kerns of the Burlington Police Department.

Upon arrival officers were able to determine that two persons who had rented a room were in possession of a 2007 Toyota SUV reported stolen from Durham. During the initial contact with the suspects in the rented room a male suspect climbed out of an exterior window, fell to the ground and fled the scene on foot.

Radio traffic heard over a police scanner indicated the man jumped from a third-floor window at Country Inn & Suites, then ran across the interstate — narrowly avoiding being hit by motor vehicles.

At some point he flagged down a driver who gave him a ride a short distance before the driver stopped and told him to get out. Police were searching an area between Longpine Road and Grand Oaks Boulevard when an employee of Holiday Inn Express called to report the man was in the motel’s lobby.

After a few minutes, police carried him seated in a chair from the building. His hands were cuffed behind him, but he was not handcuffed to the chair. The man appeared to be either gasping for air or sobbing.

Michael Garner is manager of Country Inn & Suites. He declined to discuss what took place at the business, but did say, “I felt the Burlington police did an excellent job.”

A further investigation revealed that the suspects had rented the room under false pretenses and both were wanted on outstanding strong armed robbery arrest warrants from Winston-Salem.

The suspects were identified as **Ruben Noel Torres**, 43, of Winston-Salem. He was **charged with felony possession of stolen goods, false pretense, felony possession of cocaine, possession of drug paraphernalia, resisting arrest and strong armed robbery.**

**The Nottoway County Sheriff’s Office in Virginia held an active fugitive from justice warrant on Torres for larceny of a motor vehicle.** Torres was being treated Thursday night at ARMC for non-life threatening injuries. He will be processed on all of the charges upon his release.

Meredith Huffman Moore, 35, of Winston-Salem was charged with felony possession of stolen goods, false pretense, felony possession of cocaine, possession of drug paraphernalia and strong armed robbery. She was held under a \$25,000 secured bond at the Alamance County Jail.

**Rodriguez was charged with 25 counts each of identity theft and obtaining money by false pretenses.** He was held in jail under a \$25,000 secured bond.

## Four men facing drug charges after Hoke County raid Friday

**RAEFORD - Four illegal immigrants were charged and authorities seized nearly \$400,000** after the Hoke County Sheriff's Office searched a home off U.S.. 401 near Raeford on Friday.

"This is probably **one of the biggest drug busts in the history of the county**," Sheriff Hubert Peterkin said Monday.

The house on the 300 block of Purvis Court, about two miles outside Raeford, was searched by the Sheriff's Office Special Operations and Drug Unit, Peterkin said.

Lawmen seized a large amount of cocaine, \$397,134 in bills that were pressed and bundled, and five guns - an AK-47, two .45-caliber handguns, a .357 Magnum and a Winchester rifle, Peterkin said.

Searchers seized a money-counting machine and five vehicles, Peterkin said.

A large quantity of cocaine was seized, Peterkin said, but he wouldn't say how much.

"The amount of trafficking this group of suspects was doing was very professional and very organized," he said.

The operation was considered a major source of cocaine for Hoke and surrounding counties, Peterkin said.

"This (investigation) is taking us out of Hoke County and out of North Carolina," he said. "We're calling for all hands on deck and for federal assistance."

The four men arrested are all charged with possession with intent to sell or deliver a controlled substance, maintaining a drug vehicle or dwelling and conspiracy to sell or deliver a controlled substance.

They are **Eusebio Ciriaco**, 28; **Jose Luis Hernandez**, 20; **Alejandro Pano Fuentes**, 35; and **Javier Patricio Anecetu**, 24.

It wasn't clear if all of the men lived at the Purvis Court address. Peterkin said the residence was used as a base for the drug operation.

Bail for each was set at \$1 million, and the **U.S. Immigration and Customs Enforcement agency has placed a detainer on all four because they are in the country illegally**, Peterkin said.

## **Two Arrested, Half Kilo Of Coke Seized In Lenoir County**

## Graham man fingered in international drug cartel crackdown

A Graham man was one of three people sentenced to federal prison Wednesday out of a drug trafficking sting in eastern North Carolina.

**Manuel Ricardo Reyes-Flores**, 65, was sentenced to 12 years six months in prison followed by five years of supervised release by a judge for the Eastern District of North Carolina U.S. District Court. He must also pay a \$5,000 fine.

On April 1, 2012, federal, state and local agents seized more than 5 kilograms of methamphetamine that **Reyes-Flores and Ricardo Salvador Flores-Carrasco, 40, of Mesa, Arizona, were transporting from Arizona into Greenville.**

“Additional investigation revealed that Reyes-Flores was also responsible for trafficking an additional 283 grams of methamphetamine, 181 kilograms of marijuana and 5 kilograms of cocaine in North Carolina,” said a release from U.S. Attorney Thomas G. Walker’s office.

The arrest was part of operation No Quarter by the Organized Crime Drug Enforcement Task Force, which includes the Drug Enforcement Administration, U.S. Department of Homeland Security, divisions of the Bureau of Alcohol Tobacco Firearms and Explosives, the Internal Revenue Service and numerous state and local law enforcement agencies around the country. No Quarter is intended to target Mexican drug cartels in North Carolina, the U.S. and Mexico.

Flores-Carrasco was sentenced to 102 months in federal prison and five years’ supervised release.

Additionally, Bobby Kemoni Latrae Wallace, 26, of Grifton, was sentenced to 36 months in prison and three years’ supervised release. Wallace was charged with selling 290 grams of cocaine to undercover officers in March and April 2010.

No Quarter has spanned 10 years and five N.C. counties, the release said. More than 100 people have been charged in North Carolina’s 44-county eastern district, and more than \$1.5 million in currency, more than \$4.6 million in drugs, along with firearms and real property have been seized by law enforcement in the operation.

## Catawba man faces 4 meth charges

## 2 Men Arrested in Synthetic Mushroom Operation Raid

GREENSBORO — Two men face charges after a raid on their home Friday led to a neighborhood's evacuation when officials found what they thought were bomb-making materials.

But the Guilford County Sheriff's Office now says those items were being used to make psilocybin, or synthetic mushrooms.

**Sayed Jafar Ahmad Mostafavi**, 26, and **Seid Michael Mostafavi**, 24, both of 2902 Regents Park Lane were **charged with possession with intent to sell and deliver marijuana, possession with intent to sell and deliver psilocybin, manufacturing psilocybin, manufacturing marijuana, and conspiracy to manufacture controlled substances.**

Based on tips from confidential sources, the Guilford County Sheriff's Office served search warrants at about 10 a.m. at the home, expecting to find a marijuana-growing operation.

But when they went inside, narcotics officers found a room covered with plastic from end to end, Col. Randy Powers said. They found fertilizer and unfamiliar chemicals in the room, as well as mason jar tops inside a pressure cooker, apparently being sterilized.

Capt. Tony Caliendo said, "Those same precursors could be used for explosives."

Detectives left the home and called for backup.

County and city law enforcement agencies, area fire departments and the Greensboro police bomb squad cordoned off the north Greensboro neighborhood and evacuated an unspecified number of residents.

Isaac Martin of 3005 Regents Park Lane said police told him they might have to evacuate houses on the street but wouldn't tell him why.

He said he has lived in his home for 30 years and hadn't seen anything like the police presence he saw Friday. Police tape stretched across Regents Park Lane at Lawndale Drive. Martin said he was told that other streets had been closed several blocks away.

Brian Clayton of 2905 Regents Park Lane had left his home, but when he returned at 2 p.m., the streets were closed.

Police didn't allow him to return home until 2:30 p.m., he said.

After the bomb squad determined the products in the home weren't explosives, they allowed narcotics investigators to return to their investigation.

Investigators found synthetic marijuana, Powers said. "We think they were growing synthetic mushrooms," he said.

Synthetic mushrooms are new to the area, Powers said.

## **Man had hundreds of doses of ecstasy**

## **Mother, daughter accused of income tax fraud**

RALEIGH, N.C. — A local tax preparer working as a government witness led to the arrest of two women charged in a tax fraud scheme involving people suspected of living in the U.S. illegally.

**The tax fraud scheme is a \$4 billion problem across the United States that involves suspected illegal immigrants getting billions of dollars in tax credits for children who don't live in America, or don't even exist**, according to the Treasury Inspector General for Tax Administration.

**Angela Flores and her daughter, Karen Mejia**, are **accused of wrongly getting more than \$60,000 in tax refunds this year**. They made their initial appearances in federal court in Raleigh on Thursday.

The criminal complaint states Flores told the tax preparer to take children from one tax return and put them on others to help cash in on the federal child tax credit.

The preparer first became a government informant in 2009 – during another tax fraud investigation involving Flores.

The scheme was so profitable that, when the preparer said he was getting heat from the IRS and \$100 per return wasn't enough, Flores and Mejia quickly agreed to start paying him \$350 cash for each return, according to court documents.

Seven months ago, WRAL Investigates highlighted a similar multimillion-dollar scheme out of the Charlotte area.

Investigators uncovered more than 1,000 tax returns last year linked to eight addresses in North Carolina, with refunds worth more than \$5 million. Agents confiscated hundreds of refund checks, lists of Hispanic names, a box of Mexican birth certificates and tax returns sent to people linked to falsified documents.

The IRS has tightened rules for child tax credits this year in an effort to fight fraud, and several people have been arrested in eastern North Carolina in recent months on fraud charges.

## **North Carolina community activist to be deported**

Charlotte- U.S. Immigration and Customs Enforcement has decided to deport a community activist and coordinator of a Catholic youth group in North Carolina after her arrest on a minor traffic violation.

ICE spokesman Vincent Picard confirmed on Wednesday to Efe that Mexican **Fabiana Palomo Muñiz "does not qualify for procedural discretion due to a previous deportation in 2003 and (her) illegal reentry into the country, which constitutes a federal crime."**

On April 9, Palomo Muñiz, who has lived in the city of Durham for eight years, was arrested in Wake County after she left the scene of a minor traffic accident in which she had been involved.

Palomo Muñiz, the coordinator of the Hispanic Youth Ministry at the Immaculate Conception Church, was driving that day to a parish event.

According to what Gustavo Peña, the immigrant's husband, told the media, she did not understand the instructions given her by police because she does not speak English and she was fined and arrested for not having a driver's license and for resisting arrest.

After the incident, she was transferred to the county jail, where she was identified as undocumented under the 287(g) program and placed in the deportation category.

Although the state's charges were thrown out last week, ICE said that soon it will transfer the woman to an immigration detention center in preparation for her later deportation.

On Monday, a vigil in support of Palomo Muñiz was held at the Immaculate Conception Church, where dozens of friends and acquaintances called for her release.

Viridiana Martinez, the founder of NC Dream Team, which organized a campaign to place telephone calls to the ICE offices and to the Wake County jail to prevent the deportation, explained Wednesday to Efe that they are not "giving up."

## Teen Charged With Vandalizing Property

## Thief nabbed by neighbors

A teen held at gunpoint last week by a man checking on a break-in report was connected by fingerprint evidence to two other break-ins at the same residence, sheriff's officials said.

**Douglas Castro Medina**, 17, was seen by a resident walking along Hog Market Road between Stantonsburg Road and U.S. 258 on April 30, Pitt County Sheriff's Office spokeswoman Christy Wallace said.

The resident was suspicious of the teen due to previous break-ins in the area and because he was wearing a black hoodie, back pack and gloves and had been seen in the area before, she said.

The neighbor phoned the property owner of 3895 Hog Market Road, where a renter had fallen victim to break-ins in March and April and lost nearly \$8,000 worth of property.

The owner responded to the area with an employee about 9 a.m. Neither man wished to be identified by name.

"We just got a tip from a neighbor the guy was walking down the road," the employee said in a phone interview on Tuesday. "He walked 200 yards past the house, ducked in a field and came back to the house."

The employee said Medina was walking from the home's side steps when they approached him.

"We just told him to get on the ground," the employee said, noting he had a gun and made Medina aware of it. "He cooperated."

Medina was held at gunpoint until deputies arrived, requested the employee secure his weapon then took the teen into custody, Wallace said.

Medina, of 3794 Goldsboro Run, reportedly told deputies he was at the residence to use a phone to get help and did not want to get in any more trouble.

**The Farmville Central High School student was charged in a November break-in nearby at a Ghost Hollow Road residence off of Stantonsburg Road. Deputies also determined Medina was a suspect in another November break-in and larceny in the same area, but the victim declined prosecution.**

**In the April 30 incident, Medina was charged with felony attempted breaking and entering and felony possession of burglary tools, Wallace said. Deputies contacted detectives to compare Medina's fingerprints to those lifted during a previous break-in investigation at the residence.**

**The prints matched those from an April 11 break-in, Wallace said, and the detective of another open case at the residence was contacted to interview Medina.**

The teen admitted to committing the three break-ins and provided a written statement to detectives, Wallace said.

On April 11, two iPods, each valued at \$150, a necklace valued at \$50 and \$98 in cash were taken, a case report shows.

Capt. Paula Dance said the teen ate popcorn and had touched a bag of sugar that he left on the counter, which ultimately led to him being linked to the previous break-ins.

“Food items he touched in the house were processed (for evidence),” she said. “Once they arrested him on the most recent one, because of other break-ins in the area, they went back and compared his prints to the prints lifted from a few of the scenes, and they were able to match them.”

Medina also was linked to a break-in between March 20 and March 30 at the Hog Market Road residence, where several items were reported stolen on April 2. A case report lists stolen items as a \$2,000 ring, another ring valued at \$1,200, a \$3,000 bracelet, \$140 in cash, headphones, shoes, a Nintendo DS and games. Value of the items totals \$7,472.92, the report indicates.

**The teen faces four additional felony charges in those incidents — two counts of breaking and entering and two counts of felony larceny after breaking and entering.**

He was booked into the Pitt County Detention Center under a \$60,000 secured bond, jail officials said. Court records show Medina faces a May 16 court date.

**Medina also has felony breaking and entering, felony larceny after breaking and entering and misdemeanor possession of stolen goods charges pending against him in a Nov. 13 break-in at 3730 Ghost Hollow Road.**

In that incident, \$70 in cash, four earrings, jeans, T-shirts, dress shirts, a jacket and hair gel — all valued at \$325 — were stolen. Dance said Medina was arrested on Dec. 5 after he walked past the home, and the victim saw that he was wearing his belongings.

The teen has a May 30 court date on those charges.

On Nov. 11, Medina's mother called the sheriff's office to report Medina and her other son had broken into a residence at 3429 Highland Drive, where a Nintendo DS valued at \$170 and \$350 cash reportedly was missing.

The victim in that case declined prosecution “and wanted to work it out between the families since they were friends,” Wallace said.

The employee who held Medina at gunpoint last week said he is glad the teen is off the streets for now.

“I feel great about it,” he said. “I hate a thief. I wish him luck. I hope he gets straight and can live and learn.”
