## Vale man charged with rape of 13-year-old

Lincoln County Sheriff's deputies arrested a Vale man on charges he raped a 13-year-old girl. **Jose Freddy Ambrosio-Gorgonio**, 32, of 7500 Palm Tree Drive, Vale, was <u>charged with three felony counts of statutory</u> <u>rape/sexual offense</u>.

Police say the girl was not related to Ambrosio-Gorgonia.

Police allege the incident happened in November. Lincoln County Social Services reported it to the Lincoln County Sheriff's Office on Jan. 17.

He was also charged with misdemeanor driving while license revoked and improper use of license plate on a vehicle.

He was given a \$150,855 bond.

## Man, 42, arrested for sexual offense with girl under 13

A 42-year-old man is accused of committing a sex offense with a 12-year-old girl, according to an arrest warrant and a police captain.

**Carlos Gumercindo Crus**, of 719 Hyde St., was arrested Friday on the <u>charge of felony first-degree sex</u> <u>offense with a child</u>. He was placed in the Davidson County Detention Center under a \$250,000 secured bond.

The Lexington Police Department alleged in an arrest warrant the sex offense occurred Friday.

Capt. Robby Rummage of the Lexington Police Department alleges the offense occurred with a <u>12-year-old girl</u> who was known to Crus.

"It was not a random act," the captain said Monday.

Rummage said the incident occurred at the child's home in Lexington. He said the girl's mother reported it to Lexington officers. Rummage said he could not provide further details regarding the case.

Crus is scheduled to appear March 10 in Lexington District Court.

## Greensboro man faces multiple sex charges involving 10-year-old Zebulon girl

RALEIGH — A 26-year-old man from Greensboro was being held Tuesday in the Wake County Detention Center in lieu of \$100,000 bail on <u>13 child-sex charges</u> that a search warrant from Zebulon police link to a 10-year-old girl and a series of pictures and videos sent in telephone messages.

Guadalupe Guillen-Martinez was arrested Saturday afternoon, according to an online arrest report, though the Wake County sheriff's system lists him only as being sentenced, a designation that does not specify a charge.

State court records show, however, that Guillen-Martinez is due in court March 7 on <u>five arrest warrants that</u> accuse him of six counts of first-degree sexual exploitation of a minor, four counts of second-degree sexual exploitation and three counts of taking indecent liberties with a child.

In the search warrant, returned to the Wake County Clerk of Court office Monday, Zebulon Detective F.E. Killette said that the case began Aug. 13.

The girl's cell phone held six videos of Guillen-Martinez and "approximately 533" pictures of the girl doing actions that Guillen-Martinez directed her to do, according to the request to search his apartment at 1616 Maplewood Lane in Greensboro.

The returned warrant shows that police seized several computers, a compact disk, other storage devices, a notebook and a cell phone when they went to the apartment on Feb. 18.

The warrant does not indicate how the girl and Guillen-Martinez came into contact.

Police said they were able to identify Guillen-Martinez through his cell phone and that even though the account had been closed, Greensboro police verified that he still lived at the address on it.

## MCSO makes arrests for alleged sex crimes against minor

Macon County Detectives were called in to investigate an allegation of crimes against a child on Sunday, Feb. 9. After a preliminary investigation, **Cirilo Pascual Reyes**, 22, of Franklin, was charged with <u>first degree rape of a child</u>.

"Mr. Pasquel [Reyes] was arrested by MCSO detectives following a thorough investigation," said Sheriff Robbie Holland. "Detectives were able to execute a search warrant at the residence where it was alleged that the crime was committed. During interviews Pasquel [Reyes] admitted to detectives that he had committed sexual offenses with the child who is under the age of 12."

Reyes was arrested and held on a bond set at \$150,000.

## Man sought on child sex charges in Harnett County

LILLINGTON, N.C. (WTVD) -- Authorities in Harnett County are searching for a man they say is wanted in connection with two sexual assaults.

**Oscar Lamar Rodriguez**, 34, who is on leave from the Army, is <u>wanted for two counts of second degree rape</u>, five counts of second degree sexual offense, one count of sexual battery, three counts of indecent liberties with a child, two counts of crime against nature, and three counts of first degree burglary.

The offenses were committed in May to August 2013 and on December 31, 2013, in the Cameron area of Harnett County.

Officials say Rodriguez was familiar with both of his victims.

He is described as a Hispanic male, with brown eyes. He is 5' 5" tall and weighing 170 pounds.

Rodriguez may be operating a Maroon Lincoln Aviator or a black Chrysler passenger car.

## Pender man pleads guilty to rape

A Pender County man was sentenced to a minimum 10 years in prison after pleading guilty Friday to two sex charges, according to a news release from the Pender County Sheriff's Office.

**Nazario Rojas Bautista** pleaded <u>guilty to second-degree rape and second-degree sexual offense</u>, Detective Sgt. John Leatherwood of the sheriff's office said.

Bautista originally was charged June 7 with assault on a female, Leatherwood said. After further investigation, Bautista was charged June 10 with first-degree rape, first-degree sexual offense, assault by strangulation and assault inflicting serious injury minor present, Leatherwood said.

Prior to his scheduled release from prison, **Bautista will be deported**, Leatherwood said.

## \$50,000 Bail Set in Greensboro Statutory Rape Case

GREENSBORO — A Greensboro man <u>faces nine charges of statutory rape in connection with assaults on a 14-year-old girl.</u>

Greensboro police charged **Jose Manuel Rodriguez**, 57, of 4027 Hewitt St., in connection with assaults on a girl that happened in October and November, according to arrest warrants.

Rodriguez also faces a charge of taking indecent liberties with a child.

Rodriguez is being held in the Guilford County jail on \$50,000 bail.

## Illegal immigrant charged with aggravated child abuse

MURFREESBORO — <u>A 35-year-old Mexican immigrant who is living in the country illegally</u> was accused of abusing his girlfriend's child for "not counting numbers correctly," according to an arrest report from the Murfreesboro Police Department.

Antonio "Tony" Moreno-Martinez, of Murfreesboro, is facing <u>aggravated child abuse charges and</u> <u>deportation back to Mexico</u> following a DCS investigation into an incident with his girlfriend's child, according to a report filed by MPD Officer Tannas Knox.

Knox said the child's mother said "her boyfriend became angry with the child due to (the child) not counting correctly. <u>The child had multiple bruises on his back, buttock, face and neck</u>."

Moreno-Martinez was placed under arrest and transported to the Rutherford County Adult Detention Center. He was booked on \$100,000 bond.

After booking, an "ICE detainer" was placed on Moreno-Martinez.

Detainers are used by the U.S. Immigration and Customs Enforcement Division of the Department of Homeland Security to "identify and ultimately remove criminal aliens who are currently in federal, state or local custody," according to the department's website.

Once Moreno-Martinez is released from the county jail, ICE will take custody of him for possible deportation, according to the ICE website.

#### **Assault Nets Arrest**

WOODLAND - A domestic argument that turned physical ended with one arrest.

On Jan. 18, Northampton Sheriff's Investigator Altessie Taylor responded to a domestic assault in Arrowhead Mobile Park, located on NC 35 north of Woodland. There the Detective spoke with <u>the victim, a 24 year old</u> <u>pregnant female</u> about the assault. The victim told law enforcement that her boyfriend, 23-year-old **Mainor Sanchez** of Woodland, had <u>kicked her in the stomach during an argument</u>.

Northampton County Sheriff Jack Smith reported that the victim obtained warrants on the suspect for assault on a female. Armed with that warrant, Northampton County law enforcement officers returned to the residence and arrested Sanchez.

Sanchez was brought to the Northampton County Sheriff's Office and processed. Smith said Sanchez was not given a bond, which is mandatory in domestic violence cases.

Sanchez is scheduled to make his first appearance in Northampton County District Court on Monday, Jan. 27.

Northampton Sheriff's Sgt. Jimmy Pair and Deputies Marcel Goffington and Patrick Jacobs assisted Investigator Taylor in the case.

## Man's Citizenship Lies Earn Him Prison Term

Raleigh | A Wilmington man was sentenced to nearly five years in prison Tuesday in federal court, according to a release from the office of the U.S. Attorney of the Eastern District of North Carolina.

**Eugenio M. David-Martinez**, 55, was <u>charged April 22 with a count of making false statements to a federal</u> <u>agency and making false claims of U.S. citizenship</u>. He pleaded guilty to those charges July 11, according to the release.

David-Martinez, who came to the United States from Cuba in 1980, according to the release, provided tax and accounting services to people residing illegally in Wilmington since at least January 2007, the release said.

As part of his practice, David-Martinez applied to become an acceptance agent, or someone who is authorized by the IRS to help others obtain Individual Taxpayer Identification Numbers.

Acceptance agents though must be U.S. citizens, and David-Martinez lied about his status in order to pass the background check.

In addition, David-Martinez said he had been authorized to practice by the IRS before.

David-Martinez also helped ITIN taxpayers negotiate IRS refund checks as part of his practice.

To charge for that service, David-Martinez needed a license from the N.C. Office of the Commissioner of Banks.

As part of the application for that license, David-Martinez again said he was a U.S. citizen.

From 2007 to 2012, David-Martinez filed about 18,536 identification number applications, receiving about \$15 apiece. He also filed about 12,985 income tax returns, charging about \$90 apiece.

Despite his status as an illegal immigrant, David-Martinez cannot be deported because he is a Cuban national.

Agencies involved in the case included the IRS-Criminal Investigation and the U.S. Department of Homeland Security, in addition to federal prosecutors.

## Three Charged in Connection with Robbery

Moore County Sheriff's investigators have arrested three men and charged them in connection with a robbery that was reported Monday afternoon, said Sheriff Neil Godfrey.

Godfrey reports that at 12:30 p.m. Monday his office received a call from Juarez Sanchez, who said he had just been robbed at his residence in Eagle Springs. Sheriff's Deputies and Investigators along with Moore County EMS units responded to the scene.

<u>Mr. Sanchez had been injured during the robbery but was treated on the scene by paramedics.</u> He told deputies three Hispanic males came to his residence, held him at gun point, and assaulted him with a pair of brass

knuckles. Mr. Sanchez advised the suspects took \$3,000 in and his Chevrolet pickup truck after threatening his life.

Investigators were able to identify the suspects with evidence from the scene and information obtained during the investigation. Investigators determined that the suspects had fled to Richmond County in an attempt to avoid capture.

After identifying the possible location of the residence where the suspects were located, investigators contacted Richmond County Sheriff Deputies, and they joined the investigation. Deputies from both agencies executed an operation that lead to the arrest of all the suspects, the recovery of the stolen vehicle, firearms, and the stolen U.S. currency.

Merida was charged with one count of felony robbery with a dangerous weapon, one count of felony second degree kidnapping, one count of assault with a deadly weapon with intent to kill, one count of felony conspiracy, one count of felony larceny of a motor vehicle.

All three men were confined in the Moore County jail under a \$200,000 secured bond pending a first court appearance set for March 11 in Moore County District Court.

## Durham police investigate fatal shooting on Liberty Street

DURHAM (WTVD) -- Durham police are searching for a suspect wanted in connection with a fatal shooting that occurred Saturday afternoon on Liberty Street.

Police say 28-year-old Alfredo D. Jobel was found lying on the sidewalk in the 1400 block of Liberty Street around 1:35 p.m. He had been shot and was pronounced dead at the scene.

Investigators say the shooting happened right in front of the victim's home.

ABC11 spoke with an eyewitness who was walking with his friends when the shots were fired. He says it was a drive-by shooting.

"This was not pretty. And for me to see this...me and my three friends...we were shaken. I'm speechless right now. Somebody just started shooting. I'm thinking its firecrackers," said eyewitness Terry Lyons.

Investigators say Jobel had been in a car when the shooting occurred. The car went out of control after the shooting and collided with another vehicle. Two people were injured when the cars collided. They were taken to the hospital for treatment and have since been released.

One family member told ABC11 Jobel left behind a newborn son.

"It's heartbreaking. I can actually feel their pain right now. I actually do feel their pain. I just don't know what caused this to happen," Lyons said.

The investigation is ongoing. No charges have been filed at this time.

Mexican National Convicted Of Murdering Former Emerald Isle, NC Coast Guardsman http://www.witn.com/home/headlines/Mexican-National-Convicted-Of-Murdering-Former-Emerald-Isle-Coast--243851511.html

A federal jury in Los Angeles has convicted a Mexican national of killing a U.S. Coast Guard crewman when he rammed a 30-foot panga boat into the vessel the victim was aboard.

The deceased crewman, Terrell Horne III, was previously stationed in Emerald Isle.

U.S. attorney's spokesman Thom Mrozek says Jose Meija Leyva was found guilty Wednesday of seconddegree murder of a federal officer.

Meija Leyva rammed his boat into a Coast Guard vessel as it approached on Dec. 2, 2012, during a drugsmuggling investigation off the coast of Southern California.

Chief Petty Officer Terrell Horne III was knocked into the water. He was fatally struck in the head by the panga boat's propeller.

Another guardsman was injured.

A second man aboard the panga, Manuel Beltran Higuera of Mexico, was <u>convicted of lesser charges</u>.

Horne worked at Coast Guard Station Emerald Isle from 2009 to 2011, before relocating to California.

## Three Arrested in East Charlotte Homicide

CHARLOTTE, N.C. – Charlotte-Mecklenburg police have arrested three people in connection to an east Charlotte murder last Monday.

Police charged Jose Mannuel Sosa, Edwin Medel and Lindy Kompeak Hoeun in the murder of Tony Van Tran.

The shooting happened Monday on Northgate Trail Drive around 6:30 p.m. According to police, there were multiple shots fired in the area.

Police said when they arrived on the scene they found shell casings but no victim. Carolinas Medical Center later called authorities after a gunshot victim arrived for treatment.

Tran, 26, died a short time later at the hospital.

Police said the three suspects knew Tran and <u>were conducting a drug transaction when he was murdered</u>. Sosa, Medel and Hoeun were <u>all charged with first degree murder</u>, <u>conspiracy to commit armed robbery and</u> <u>two counts of armed robbery</u>.

DURHAM (WTVD) -- Some Durham city leaders are preparing to take a strong stance against vandals planning to protest the police custody death of Jesus Huerta.

Since November, heavily armed officers and protestors have faced off, resulting in thousands of dollars worth of damage to city property.

City leaders say the Jan. 19 march resulted in \$5,000 in damage to a police substation and state property along with \$17,000 in overtime for police officers.

It is the reason why a city council member says he has drafted a resolution with the hope of preventing similar vandalism on Feb. 19.

Protesters and supporters of Jesus Huerta's family have said they would mark the date of the teen's tragic death until they get answers.

The family is still waiting for the police department's final report of the incident.

Investigators have said Huerta died from a self-inflicted gunshot wound from a weapon he was carrying. No charges will be filed in the case.

However, the SBI and the Durham District Attorney's Office are reviewing new information the teen's family has provided.

Meanwhile, city leaders say they can no longer bend the rules for the protesters who have marched without a permit and in the evening, which are both violations of the law, according to Durham city council member Eugene Brown.

"We're just going to send a message to those who'll participate Feb. 19 that these are the rules and if you break the rules there will be consequences to pay. And the response by police will be proportional to the extent of their activities. Enough is enough," Brown said.

Brown says his fellow council members will first have to approve the resolution he has created. He says the council plans to discuss it as early as Thursday.

## Police identify victim of fatal worksite incident in Shelby

A Shelby Police report reveals the identity of a man killed in a recent industrial incident at a local construction site and releases more details about the incident.

**Jose Alexander Narvaez**, 52, of Charlotte, was killed Friday when the cap of a pipe struck him in the head at the site of the new KSM Castings manufacturing plant off Plato Lee Road in west Shelby, according to the report released this week by police.

When police arrived, EMS was on scene putting Narvaez on a heart monitor, officers said in the report, and when no heartbeat was found, EMS contacted the coroner's office.

"There was severe trauma to the victim's head. A construction worker advised the victim was removing a cap from a pipe approximately 12 inches in diameter," the report reads.

Narvaez was loosening the bolts that held the cap on when the incident happened, police said. A worker who spoke with police said he walked around a corner away from Narvaez and then heard a loud boom.

"The construction worker said that the cap was under pressure and blew off, striking the victim in the face," according to the report.

<u>Narvaez worked for United Mechanical Corporation, a subcontractor at the site of KSM Castings</u>, an auto parts manufacturer that announced plans in February 2013 to bring almost 200 jobs to the Foothills Commerce Facility in Shelby. The company recently started the process of hiring workers for the facility.

#### Man Killed in Winston-Salem Crash

A Winston-Salem man was killed in a single-vehicle crash early Monday morning.

**Rene Quiterio Medel**, 27, died in the crash just after 6 a.m. in the 2700 block of Cole Road between Interstate 40 and Highway 311.

Medel's Honda Civic was going east on Cole Road when the car went off the road to the right, went down an embankment and crashed into several small trees, Winston-Salem police said.

The trees forced the car to rotate and face westbound, police said. Medel was pronounced dead at the scene.

The investigation continues. Speed and alcohol appear to be factors in the crash, police said.

#### Authorities seize drugs and cash in undercover bust

David Timothy Harris, 47, of Charlotte; **Jesus Roberto Teran Valdivia**, 41, of Monroe; and **Tomas Ramirez**, 30, of Charlotte, were arrested by the Union County Sheriff's Office in the parking lot of a Lowe's store in Monroe, detectives said.

Officials said they found roughly 21 pounds of marijuana – with an estimated street value of \$35,000 – at that time.

After the arrests, detectives searched a residence on Crowder Road in Monroe – the same address Valdivia gave authorities – and said they seized additional drug paraphernalia and evidence.

Investigators requested assistance from Charlotte-Mecklenburg police in order to search several homes in Mecklenburg County.

Police seized \$119,000 in U.S. currency and nearly 10 more pounds of marijuana, with the approximate street value of \$16,000, at Harris's home on Vintage Lane, officials said.

Harris has been charged with conspiracy to traffic in marijuana, trafficking in marijuana, maintain a vehicle to store controlled substances and possession of drug paraphernalia, officials said. He's being held on \$115,000 secured bond.

Valdivia has been charged with conspiracy to traffic in marijuana with a \$25,000 secured bond.

Ramirez has been charged with conspiracy to traffic in marijuana, trafficking in marijuana and possession of drug paraphernalia. He is jailed under \$100,000 secured bond.

All three men remain in custody Friday at the Union County Jail and are scheduled for their first court appearance on March 11, officials said.

## Firefighters uncover \$100K in drugs after mobile home fire

ALEXANDER COUNTY, N.C. — After going through a charred out mobile home in Alexander County, firefighters uncovered more than \$100,000 worth of drugs.

Investigators think the men who were living inside may be connected to a Mexican drug cartel.

"We come in here and found the poker table and the money-counting machine," said Vashti Fire Chief Steven Carson.

Carson showed us what's left of the home north of Taylorsville. Not only did they find cash but also a large amount of drugs in this bedroom. Sheriff's deputies said they recovered 26 pounds of pot, cocaine and meth from the mobile home.

<u>Deputies believe the home was a stash house for drugs originating in Mexico</u>. Investigators said the fire started near the fireplace and then burned out of control.

They believe the flames were so intense the renters had to take off without time to take the drugs.

"They were trying to stay warm with the fireplace and in reality it brought down the heat on them," said Deputy Chief Tod Jones with Alexander County Sheriff's Office.

The mobile home is in a rural part of the county. There are few neighbors nearby and a Channel 9 reporter said he hasn't seen too many people today driving down the road.

Even the home's owner was fooled by the men renting from him. Homeowner Jerry Wike said the men said they worked somewhere near Winston.

<u>Deputies believe the men have left the area, possibly en route to Mexico</u>. The drugs are valued in excess of \$100,000. Much of the home was destroyed by the fire but it was what was found inside that the fire chief will remember.

"It is a very quiet, close-knit community. Just a real shock to find that much out here," Carson said.

## Wanted Columbus Co Man arrested on Drug Charges

COLUMBUS COUNTY, NC (WECT) – A Columbus County man was taken into custody five months after a warrant was originally drafted for his arrest as part of *Operation Locktoberfest 2013*.

**Jose Luis Flores**, 43, was arrested Thursday and <u>charged with 1 count of Sell and Delivery of a Scheduled 2</u> <u>Controlled Substance, oxycodone</u>. He was wanted as part of the September drug round up by the by the Columbus County Sheriff's Office.

Flores sold the oxycodone tablets to a confidential informant who bought the drugs in order to resell them. This transaction was made by the Columbus County Sheriff's Vice-Narcotices Detective Dustin Fowler.

Flores was arrested during a traffic stop near the North and South Carolina border. <u>He had been dodging</u> <u>deputies by living in different homes inside and out of the county.</u>

Originally, 41 people were arrested in connection to the two-month investigation in which undercover agents spent about \$10,000 to buy drugs

## Wake County deputies seize 12 pounds of methamphetamine

RALEIGH — Wake County sheriff's deputies made two arrests and seized 12 pounds of methamphetamine Wednesday afternoon, after stopping a car and searching it.

One of the two men arrested, **Jose Angel Diaz**, 23, initially was listed as living in Georgia, as have suspects arrested in two other highway meth busts by sheriff's investigators, one last month that netted 24 pounds and one in October, when 51 pounds were seized.

When booked, however, Diaz and **Paul Manzanares Velazquez**, 20, both were listed as living at 312 E. Cedar St. in Yadkinville.

Each was charged with two counts of trafficking in methamphetamine and one count of conspiring with the other to traffic, arrest warrants said.

<u>Velazquez also was charged with maintaining</u> the 2004 Honda Odyssey that deputies stopped at Interstate 540 and Capital Boulevard about 5 p.m.

Investigators do not usually discuss drug investigations that lead to specific arrests, but many stem from an ongoing effort by a task force that combines federal, state, county and local law enforcement officers.

Federal authorities placed requests for both men, who are Mexican natives, to be held while officials look into their immigration status.

Each man was being held in lieu of \$1.5 million bail for a court appearance Thursday.

## Two charged in Johnston, one in Wake with Cocaine Trafficking

Each man was charged with two counts of cocaine trafficking – one for manufacturing and one for possession – two counts of conspiring to traffic and one misdemeanor count of possession of drug paraphernalia.

About 9:30 p.m. Saturday, Wake deputies arrested **Alejandro Garcia-Ponce**, 28, of 435 Sir David Drive, near Zebulon, and seized between 28 and 200 grams of cocaine, an arrest warrant stated.

Twenty-eight grams is the threshold for someone to be charged with trafficking rather than possession with intent to sell, a less-serious felony.

Garcia-Ponce was also charged with maintaining a 2005 Chevrolet Equinox as a place to keep and sell drugs.

A second warrant accused Garcia-Ponce of possession with intent to sell or deliver the drug, saying he sold cocaine to a police informant on Jan. 18.

Silva and Millan were each being held in lieu of \$510,000 bail.

Garcia-Ponce was being held in lieu of \$101,000 bail on the drug charges and two arrest warrants saying he had missed court dates last year

## Six kilos of cocaine are seized

ST. PAULS — Five people and hundreds of thousands of dollars in cocaine are now in the custody of the Robeson County Sheriff's Office following a drug bust by narcotics agents.

County and federal agents found 5 kilograms of cocaine while searching a home at 139 Snowhill Road on Friday afternoon, according to a statement from the Sheriff's Office. Another kilogram was found in a secret compartment in one of two cars the agents searched and seized, the statement said. The vehicle was being used to transport the drugs, the statement said.

According to a 2011 report by the United Nations Office on Drugs and Crime, a gram of cocaine costs about \$120 on the street in the United States. Six kilograms is equal to about 13.23 pounds, putting its value at \$720,000.

Simone Kearns, 47; Andrea Chaidez-Cota, 54; Rene Lopez-Rodriguez, 37; Arturo Rojas-Marban, 25; and Jose Angel Meza-Cano, 26; are all charged with trafficking cocaine and conspiring to traffic cocaine, the statement said.

Rojas-Marban and Meza-Cano live at the Snowhill Road home. Lopez-Rodriguez lives at a different address in Red Springs. Kearns and Chaidez-Cota are from Phoenix.

They are all being held at the Robeson County Detention Center under a bond of \$1 million each.

## Man dies after ejected from car, badly burned in wreck

## Wilmington Tax Preparer Sentenced to 57 Months for making False Statements to IRS and the N.C. Banking Commission

**RALEIGH** – United States Attorney Thomas G. Walker announced that today in federal court, Senior United States District Judge W. Earl Britt sentenced **Eugenio M. David-Martinez**, age 55, of Wilmington, North Carolina, to 57 months imprisonment, followed by 3 years of supervised release.

**David-Martinez** was named in a two-count Criminal Information filed on April 22, 2013, charging him with Making False Statements to a Federal Agency and Making False Claims of US Citizenship. On July 11, 2013, David-Martinez pled guilty to those charges.

According to the investigation, DAVID-MARTINEZ came to the United States from Cuba in 1980. Since then, he has illegally resided in the United States. As a Cuban national, however, he is not deportable.

Since at least January 2007, DAIVD-MARTINEZ has provided tax and accounting services, in Wilmington, North Carolina. The majority of his clients were also residing in the United States illegally. In order to file income tax returns, DAVID-MARTINEZ's clients required Individual Taxpayer Identification Numbers, otherwise referred to as ITINs. To obtain an ITIN, the applicant must submit proof of identification and a tax reason for filing a return, which includes earning wages in the United States. The IRS authorizes individuals, known as acceptance agents, to assist applicants in the ITIN process. To become an acceptance agent, the individual must prove that he is a citizen or a legal resident and pass a suitability background check. In his applications to become an acceptance agent, DAVID-MARTINEZ falsely stated that he was a US citizen and bypassed the suitability background check by falsely representing he had previously been authorized to practice before the IRS as an Enrolled Agent.

For the years 2007 through 2012, DAVID-MARTINEZ filed approximately 18,536 ITIN applications for which he received \$15 per application. He also filed approximately 12,985 income tax returns for individuals with ITINs for which he charged on average \$90 per return.

DAVID-MARTINEZ also negotiated the IRS refund checks issued to the ITIN taxpayers. To advertise or offer this check cashing service for a fee, DAVID-MARTINEZ required a check-cashing license issued by the North Carolina Office of the Commissioner of Banks. The application required DAVID-MARTINEZ to indicate his country of citizenship. DAVID-MARTINEZ falsely claimed he was a US citizen.

"An integral part of the IRS-Criminal Investigation's mission involves detecting and catching fraudulent tax refund claims," stated Jeannine A. Hammett, Internal Revenue Service-Criminal Investigation Special Agent in Charge. "The IRS-Criminal Investigation will continue to aggressively pursue those who file false tax returns to claim tax refunds for which they are not entitled."

The Investigation of this case was conducted by the IRS-Criminal Investigation and the US Department of Homeland Security. Assistant United States Attorney Susan Menzer represented the government.

## Charlotte Man Sentenced to 60 Years in Prison for Marijuana Trafficking, Money Laundering and Gun Offenses

CHARLOTTE, N.C. – U.S. District Court Judge Robert J. Conrad, Jr. sentenced today Parker Antron Coleman, 28, of Charlotte to 30 years in prison for marijuana trafficking and money laundering, plus a consecutive 30 years for firearms offenses, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina. Coleman was also ordered to serve 10 years of supervised release.

U.S. Attorney Tompkins is joined in making today's announcement by Brock D. Nicholson, Special Agent in Charge of ICE/Homeland Security Investigations (HSI) in Atlanta and the Carolinas and Chief Rodney D. Monroe of the Charlotte-Mecklenburg Police Department.

According to evidence presented at his trial and other court records, Coleman was the head of a drug trafficking conspiracy that transported and distributed more than four tons of marijuana in the Charlotte area. <u>Court records indicate that Coleman's suppliers were linked to California-based</u> <u>members of the "Mexican Mafia" drug trafficking organization</u>. According to trial evidence and filed court documents, <u>the drug organization had "couriers" who used commercial flights to travel</u> <u>between the two states</u>, each time transporting approximately \$50,000 in cash to California, and returning to Charlotte with approximately 100 pounds of marijuana in checked baggage. An accomplice working at the airport in California assisted the couriers with passing their luggage containing the drugs through airport security. Coleman convinced friends and family members, among others, to act as couriers for him, as well as his own probation officer who became a "lieutenant" in his drug organization. Trial evidence demonstrated that couriers for the organization

made well in excess of 100 such round trips.

Court records indicate that on November 2, 2010, law enforcement recovered \$117,595 at the airport from two of Coleman's couriers and approximately 30 pounds of marijuana from the South Park residence of one of Coleman's co-conspirators. Upon executing a search warrant on the same day, law enforcement also recovered \$92,577 in cash, a semi-automatic handgun, large quantities of drug trafficking paraphernalia and money laundering evidence from Coleman's residence. Coleman initially denied owning the residence however, law enforcement recovered information that tied the property to the defendant, including business records, photographs, and exotic fish and aquarium equipment worth over \$15,000.

On November 16, 2010, law enforcement arrested Coleman and seized two handguns hidden in a secret compartment in Coleman's luxury SUV. Coleman is a convicted felon and is therefore prohibited from carrying and/or owning a firearm.

Coleman's prosecution stems from operation "Goldilocks," an Organized Crime Drug Enforcement Task Force (OCDETF) investigation that began in January 2009 and has resulted in the federal prosecution of approximately 70 individuals involved in the drug conspiracy.

"Coleman trafficked tons of marijuana into Charlotte and profited from spreading drugs in the city he grew up in. Today's sentence is the capstone to a multi-year international drug trafficking investigation that has dismantled a major drug organization and has landed over 60 defendants in federal prison," said U.S. Attorney Tompkins.

"As the head of a significant drug trafficking organization in Charlotte, the defendant controlled the smuggling and distribution of large amounts of marijuana," said Brock D. Nicholson, special agent in charge of HSI Atlanta, who oversees agency investigations in Georgia and the Carolinas. "Working with great partners and teamwork under the Organized Crime Drug Enforcement Task Force model, HSI special agents and Charlotte-Mecklenburg officers have disrupted and dismantled this cell and crippled their operations in North Carolina and California."

"I commend our agency partners for all their hard work and diligence in helping to dismantle and disrupt drug trafficking activities between here and California," said Chief Rodney Monroe, Charlotte-Mecklenburg Police Department. "With the turn of events, there is now one less drug trafficking organization plaguing our community."

Coleman's sentence was enhanced due to prior felony convictions. He has been in local federal custody since his November 2010 arrest and will be transferred to the custody of the Federal Bureau of Prisons upon designation of a facility. Federal sentences are served without parole.

U.S. Attorney Tompkins credited special agents of ICE HSI and CMPD officers for the investigation leading to today's sentence. The prosecution was handled by Assistant United States Attorney Steven R. Kaufman of the U.S. Attorney's Office in Charlotte.

## Federal Jury Returns Guilty Verdict for Cocaine Trafficker

CHARLOTTE, NC B A Charlotte federal jury convicted today **Pedro Oscar Dieguez**, also known as "The Cuban," 48, of Indian Trail, N.C., on <u>cocaine trafficking and related charges</u>, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina.

U.S. Attorney Tompkins is joined in making today's announcement by Harry S. Sommers, Special Agent in Charge of the Atlanta Field Division of the Drug Enforcement Administration (DEA), which oversees the Charlotte District Office; Sheriff Eddie Cathey of the Union County Sheriff's Office (UCSO), and Chief Rodney D. Monroe of the Charlotte-Mecklenburg Police Department (CMPD).

According to filed court documents and evidence presented at trial:

From about 2004 through 2013, **Dieguez** – a Cuban national – and his co-conspirators obtained more than 700 kilograms of cocaine from Mexican cartels (or other sources of supply with connections to cartels), transported it using trucks to the Charlotte area, and redistributed it for ultimate sale as crack cocaine. The current street value of that amount of cocaine is in excess of \$21,000,000. Dieguez conspired to launder the drug proceeds through bank accounts and the purchase of expensive exotic horses, which he kept on his 16-acre ranch residence in Indian Trail. The defendant also used his ranch to offload shipments of drugs. Following a four-day trial, the Charlotte jury convicted Dieguez of conspiracy to distribute and to possess with intent to distribute cocaine and conspiracy to launder proceeds of drug trafficking.

Dieguez has been in the federal custody since April 24, 2013. Dieguez faces a statutory mandatory minimum sentence of 10 years to life in prison, and a fine of up to \$10,000,000. A sentencing date has not been set yet.

The case was investigated by the DEA in Charlotte, UCSO, and CMPD. The prosecution was handled by Assistant U.S. Attorney Steven R. Kaufman.

## DRUG TRAFFICKER SENTENCED IN OPERATION "NO QUARTER"

RALEIGH - United States Attorney Thomas G. Walker announced that in federal court today Chief United States District Judge James C. Dever III sentenced **JESUS TORRES PORTILLO**, 23, of Burlington, North Carolina, to 120 months of imprisonment and 3 years of supervised release.

PORTILLO previously pled guilty to conspiracy to distribute 5 kilograms or more of cocaine.

On November 9, 2011, PORTILLO arranged for approximately 5 kilograms of cocaine to be delivered to a DEA informant in Greenville, N.C. The two couriers were arrested after approximately 5 kilograms of cocaine were found in the trunk of the car they were driving.

On November 14, 2013, PORTILLO arranged for approximately 3 kilograms of cocaine to be delivered to the informant in Goldsboro, N.C. PORTILLO was arrested after approximately 3 kilograms of cocaine were found in the truck in which he was a passenger. Further investigation revealed that, in addition to the approximate 8 kilograms of cocaine seized, PORTILLO was responsible for the distribution of 3,100 pounds of marijuana.

The Organized Crime Drug Enforcement Task Force (OCDETF) Operation "No Quarter" was designed to attack the infrastructure of the Mexican Drug Trafficking Organizations (DTO), including those of the Los Zetas, La Familia, Gulf and Sinaloa drug cartels, operating not only in the Eastern District of North Carolina, but throughout North Carolina, the United States and Mexico. These DTO's are responsible for the importation of large quantities of cocaine, marijuana, heroin, and methamphetamine into the United States, as well as the related remittance of illegal drug proceeds back into Mexico.

The investigation spanned ten years and five North Carolina counties. As part of the investigation, over 100 individuals have been charged by indictment or criminal information in the Eastern District of North Carolina and state courts. Law enforcement officials seized drugs with a street value \$4.6 million, including 127 kilograms of cocaine, 53 pounds of crystal methamphetamine, 160 pounds of marijuana, and 32 grams of heroin. Additionally, \$2.2 million in U.S. Currency, 35 firearms and 35 real properties valued at \$1.5 million were seized by law enforcement authorities.

Investigation of this case was conducted by the Drug Enforcement Administration (DEA) -Raleigh and Greensboro Resident Offices, the New York Field Division and numerous other DEA offices in the United States and Mexico; the Internal Revenue Service - Criminal Investigations; the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) - Raleigh and Wilmington offices; the United States Marshals Service; the United States Immigration and Customs Enforcement (ICE), Homeland Security Investigations (HSI) - Raleigh and Tampa, Florida offices; the North Carolina State Bureau of Investigation; the North Carolina National Guard; the North Carolina State Highway Patrol; the Greenville Police Department; the Pitt County Sheriff's Office; the Pamlico County Sheriff's Office; the Lenoir County Sheriff's Office; the Craven County Sheriff's Office; the Carteret County Sheriff's Office; the Beaufort County Sheriff's Office; the New Bern Police Department, the Wayne County Sheriff's Office; the Person County Sheriff's Office; the Farmville Police Department; the Goldsboro Police Department; the Rocky Mount Police Department; the Burlington Police Department, the Alamance County Sheriff's Office, and the Wilson Police Department.

The federal prosecutions were handled by Special Assistant United States Attorneys Glenn Perry and Augustus Willis, IV. Mr. Perry is a prosecutor with the Pitt County District Attorney's Office. Mr. Willis is a prosecutor with the Carteret, Craven and Pamlico Counties District Attorney's Office. District Attorneys Kimberly Robb and Scott Thomas have assigned Mr. Perry and Mr. Willis to the United States Attorney's Office to prosecute federal Organized Crime Drug Enforcement Task Force criminal matters. Their assignments to the United States Attorney's Office have been made possible by grants funded by the Governor's Crime Commission.

ASHEVILLE, N.C. – Twelve members of a methamphetamine trafficking ring have been charged with conspiracy to possess with intent to distribute methamphetamine. Seven of those charged were arrested on Tuesday, December 10, 2013, during an early morning round-up conducted by federal, state and local law enforcement, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina. Three of the named defendants remain fugitives (please see attached photos).

U.S. Attorney Tompkins is joined in making today's announcement by Harry S. Sommers, Special Agent in Charge of the Atlanta Field Division of the Drug Enforcement Administration (DEA), which oversees the Charlotte District Office and Wayne L. Dixie, Special Agent in Charge of the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF).

The arrests are the result of a multi-agency investigation to target and reduce the trafficking of methamphetamine in Western North Carolina and was conducted by DEA, ATF, the North Carolina State Bureau of Investigation, the North Carolina State Highway Patrol, the Marion Police Department, the McDowell County Sheriff's Office, the Yancey County Sheriff's Office, the Rutherford County Sheriff's Office, as well as the South Carolina Law Enforcement Division, the Cowpens Police Department and the Spartanburg County Sheriff's Office in South Carolina.

According to allegations contained in the criminal indictment unsealed on Wednesday, December 11, 2013 in U.S. District Court, from about June 2011 to July 2013, the defendants did knowingly conspire to possess with intent to distribute more than 50 grams of actual methamphetamine or more than 500 grams of a mixture or substance containing a detectable amount of methamphetamine. The indictment alleges that the defendants carried out their drug conspiracy primarily in Buncombe, Cleveland and McDowell counties in Western North Carolina.

The following individuals were named and charged in the methamphetamine conspiracy indictment.

- Carlos Alvarado Mendoza (a/k/a "Tequila"), 39 of Candler, N.C. (in custody)
- John Louis Pivonka, 42 of Marion. (in custody)
- Tommy Ray Sisk, 56 of Old Fort, N.C. (in custody)

- John Matthew Frady, (a/k/a "Ghost"), 39, of Cowpens, S.C. (in state custody)
- Jeffrey Kirkland, 41, of Gainesville, Ga. (in federal custody in Georgia)
- Miguel Santos-Maldonado (a/k/a "Mateo Segura"), 42, of Gainesville, Ga. (fugitive)
- Rigoberto Alvarado Mendoza (a/k/a "Big Boy"), 42 of Arden, N.C.(fugitive)
- Taide Alvarado Vergara, 27, of Candler. (fugitive)

All twelve defendants in the methamphetamine trafficking ring have been charged with engaging in a narcotics conspiracy and they face a statutory minimum prison term of ten years and a maximum term of life imprisonment, and a \$10 million fine. (See chart below for a breakdown of additional federal charges and maximum penalties for each defendant).

The seven defendants arrested in North Carolina had their arraignment and detention hearings on Monday, December 16, 2013, before U.S. District Court before U.S. Magistrate Judge Dennis L. Howell. All seven were detained pending trial.

The charges contained in the indictment are allegations. The defendants are presumed innocent unless and until proven guilty beyond reasonable doubt in a court of law.

The investigation is being handled by DEA, ATF, the North Carolina State Bureau of Investigation, the North Carolina State Highway Patrol, the Marion Police Department, the McDowell County Sheriff's Office, the Yancey County Sheriff's Office, the Rutherford County Sheriff's Office, as well as the South Carolina Law Enforcement Division, the Cowpens Police Department and the Spartanburg County Sheriff's Office in South Carolina.

The prosecution is being handled for the government by Assistant U.S. Attorney Thomas Kent of the U.S. Attorney's Office in Asheville.

Winston-Salem Man Sentenced For Gun Smuggling And Firearm Offenses http://www.justice.gov/usao/ncm/news/2013/12\_10\_13.html

**GREENSBORO, N.C.** – A Winston-Salem man was sentenced to 157 months in prison for his role as the leader of a <u>smuggling ring funneling firearms and ammunition to Mexico from North</u> <u>Carolina</u>, announced United States Attorney Ripley Rand.

**Angel Medel Lorenzo**, 56, of Winston-Salem, North Carolina, had pleaded guilty to conspiring to smuggle firearms and firearm accessories to Mexico and possession of a firearm in furtherance of a drug trafficking offense. He was sentenced by Chief United States District Judge William L. Osteen, Jr., to 157 months imprisonment followed by 5 years of supervised release.

During an investigation conducted by the U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI), the Federal Bureau of Investigation (FBI), the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), and the Winston-Salem Police Department (WSPD), officers seized multiple firearms, firearm scopes, and hundreds of rounds of ammunition. As part of a drug investigation by the WSPD's Special Investigations Division, detectives searched Medel Lorenzo's residence on October 19, 2011, and found multiple handguns, rifles, ammunition, cocaine, digital scales and rifle scopes. In July 2012, a reliable FBI Confidential Informant (CI) provided information that Medel Lorenzo was organizing a load of firearms to be smuggled into Mexico from Winston-Salem, NC. Thereafter, law enforcement monitored a meeting between Medel Lorenzo, the CI, and other members of the smuggling conspiracy concerning the planned shipment of a 16-gun load of firearms to Guerrero, Mexico.

On July 24, 2012, authorities executed a federal search warrant at the residence of co-defendant Ramiro Alejandro Garcia Roman on East Sprague Street in Winston-Salem and recovered a shipment of 16 firearms, hundreds of rounds of ammunition, and other firearms accessories wrapped in plastic and black electrical tape. <u>The investigation revealed that Medel Lorenzo had</u> <u>been smuggling firearms to Mexico since February of 2011 and that he used his teenage children to</u> <u>assist in packaging the firearms for transport. Co-defendants Ramiro Garcia Roman and Medel</u> <u>Lorenzo's daughter, Inocensia Medel Banos, were each sentenced in July of 2013 to 46 months in</u> <u>federal prison for their roles in the smuggling conspiracy.</u>

"The drug cartels of Mexico have shown countless times they have very little regard for human life," said Special Agent in Charge Brock D. Nicholson, head of U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI) in Georgia and the Carolinas. "Without question, the defendant was trying to get the weapons and ammunition seized in this case into Mexico to be used by these same cartel members. We are thankful for the help from the FBI, ATF, the Winston-Salem Police Department and the U.S. Attorney's Office in putting a dangerous man in prison and in stopping this smuggling scheme."

"This prosecution is a testament to the results that can be achieved through coordinated investigative efforts by the law enforcement community," said United States Attorney Ripley Rand. "Choking off the illegal export of firearms by prosecuting smugglers is important in reducing the threat that the guns will be used in violent crime. HSI, FBI, ATF and the Winston-Salem Police Department all played critical roles in exposing this gun smuggling network, enabling our office to successfully prosecute this organization."

Moore County Residents, Company Indicted For Conspiracy To Defraud http://www.justice.gov/usao/ncm/news/2014/02\_07\_14.html

GREENSBORO, N.C. – United States Attorney Ripley Rand announced today that Craig Stanford Eury, Jr., Sarah Elizabeth Farrell, and International Labor Management Corporation (ILMC) were indicted by a federal grand jury in Greensboro, North Carolina, for allegedly (1) obtaining Visas by fraud, (2) encouraging and

inducing aliens to enter and reside in the United States for commercial advantage or private financial gain, and (3) performing monetary transactions with criminal proceeds. Eury and Farrell served as officers of ILMC.

The indictment alleges that Eury, Farrell, and ILMC <u>engaged in fraudulent practices in obtaining H-2B Visas</u> and H-2A Agricultural Visas. The H-2B Visa Program includes a statutory numerical limit, or "cap," which provides that a maximum number of 66,000 aliens may be issued a visa or otherwise provided H-2B status (including through a change of status) during any fiscal year. ILMC allegedly avoided the operation of the cap by obtaining extra visas. These extra visas were allegedly used to provide H-2B workers to employers who were barred by the cap from employing alien workers. As set forth in the Indictment, ILMC profited by charging clients both for obtaining the visas for the original employer and then "transferring" the visas to a new, capbarred employer. By acquiring extra visas, ILMC allegedly gained an unfair market advantage on H-2B Visas, as those visas were then not available for employers who complied with the law.

"This Indictment against International Labor Management Corporation founder and owner Craig Stanford Eury, Jr., and President Sarah Elizabeth Farrell sends a strong message to those who would attempt to commit these types of crimes. Diplomatic Security is firmly committed to working with the U.S. Attorney's Office, the Department of Labor, the Internal Revenue Service, as well as other law enforcement agencies, to investigate and bring those who commit these crimes to justice," said Niall Meehan, Special Agent in Charge of the Washington Field Office of the U.S. Department of State's Diplomatic Security Service.

The case is being investigated by the U.S. Department of Labor, Office of Inspector General, Office of Labor Racketeering and Fraud Investigations; U.S. Department of State's Diplomatic Security Service, and the Internal Revenue Service, Criminal Investigations. The case is being prosecuted by Assistant United States Attorney Frank Chut.
