A Forsyth County man was convicted of first-degree rape and other sex offenses last week in Forsyth Superior Court.

Fidel Antonio Orellana, 39, entered an Alford plea Jan. 8 to first-degree rape, which means that he did not admit guilt but acknowledged that prosecutors had enough evidence to convict him if the case had gone to trial.

Orellana, who had no known address, pleaded guilty to two counts of statutory rape, according to court documents.

He is accused of sexually assaulting a girl who was under 13 between 2005 and 2011. Judge John O. Craig of Forsyth Superior Court consolidated the charges and sentenced Orellana to 18 years and four months to 22 years and nine months in prison.

Orellana will have to register as a sex offender for the rest of his life upon his release from prison and he will be subject to satellite-based monitoring.
