Smithfield Police said a 4 year-old child was victimized by a stranger while at a birthday party on Saturday.

Two off-duty police officers were working security at the event when a woman approached them saying she could not find her 4 year-old son. The woman said she last saw her son playing with other children and an adult male.

Police said they found the 4 year-old alone with the adult.

Police spokesman Lt. R.K. Powell said the suspect, **Jose Luis Bellez Perez**, 25, of Gason Street, Smithfield allegedly inappropriately touched and kissed the child. Lt. Powell said the victim and suspect were not related and Perez was a complete stranger to the child.

Perez was taken into custody and <u>charged with felony indecent liberties with a child and misdemeanor assault</u> on a child under age 12. Perez was confined in the Johnston County Jail under a \$87,500 bond.

According to his arrest report, <u>Perez failed to appear in Nash County court in November 2011 for a ticket for driving without a license.</u>
