SOUTHERN PINES - A Southern Pines man has been charged with first-degree murder.

Claudio Daniel Castillo, 18, was arrested Saturday after police found Wilbaldo Balbuena, 31, at 1225 Central Drive with a head injury, according to a news release from the Southern Pines Police Department.

Lt. Rodney Hardy said Balbuena died while being flown to UNC Hospitals in Chapel Hill. Police believe he was hit in the head with a shovel.

Hardy said officers responded to a 911 call made by a third party at 1:54 a.m. at Castillo's home at a mobile home park. Balbuena also lived in the park, Hardy said.

Castillo is being held in the Moore County Detention Center without bail.

Investigators issued an Amber Alert, but Ventura returned home with the child later Tuesday morning.

Njiraini is an employee of Central Regional Hospital, a state mental hospital with facilities in Raleigh and Butner, according to the warrant. It is not clear from the document whether the

charges are in any way related to his job at the hospital, which treats both adults and children with serious mental illnesses.

Njiraini was being held in the Wake County jail Wednesday night in lieu of \$200,000 bail.

Home invasion suspect arrested

DURHAM -- Police have arrested a suspect they allege was involved with committing four armed home invasions within four days last week.

Jose Javier Reyes Marquez, 36, of Weather Hill Circle, had previously been charged with four counts of robbery with a dangerous weapon, seven counts of second-degree kidnapping, four counts of breaking and entering, one count of larceny and one count of possession of a stolen firearm in the case.

Online jail records indicate that he has since been charged with at least one count of first-degree kidnapping.

Marquez has been held in the Durham County Jail since Friday in lieu of \$5 million bond, \$3 million on charges related directly to the armed home invasions and second-degree kidnapping charges and \$2 million on the first-degree kidnapping charge.

Marquez was arrested after Durham Police Sgt. Michael Berendsen stopped a blue Chevrolet Malibu on Guess Road near Fawn Avenue around 9:45 a.m. Friday. The suspect had fled in a blue Malibu in at least one of the robberies. Officers found two guns and several other items in the car.

Man held in 3-year-old DWI Death

WINSTON-SALEM- Police have charged a local man with felony death by vehicle and driving while impaired. The charges stem from an incident in the northwest corner of Winston-Salem three years ago.

Roberto Gonzalez Tellez, 25, of 5057 Natalie Temple Lane in Winston-Salem was arrested Friday after a routine traffic stop that showed him wanted on an outstanding warrant from March 7, 2007.

Police charged him in connection with an incident April 15, 2006, in the 5600 block of Shattalon Drive that resulted in the death of Juan Manuel-Pascual Pacheco. Tellez was being held last night in the Forsyth County Jail. His bond is set at \$500,000.

He is scheduled to appear in court July 24.

Father and son arrested on cocaine charges

A father and son duo from Brunswick County were arrested Thursday by vice detectives with the New Hanover County Sheriff's Office and charged with cocaine trafficking.

The arrests are the first of a weeks-long drug sting that, so far, has netted \$246,000 worth of cocaine and \$40,000 in cash.

Luis Hernandez, 38, and Oscar Hernandez, 19, both of Leland, were arrested in a parking lot near the 300 block of South College Road on Thursday and charged with cocaine trafficking and other charges, according to a news release from the New Hanover County Sheriff's Office. Both are being held in the New Hanover County jail. Luis Hernandez had a bond set at \$1.5 million, while Oscar Hernandez is in on a \$100,000 bond.

The two were charged with eight offenses each, including four counts of trafficking cocaine, conspiring to traffic in cocaine, possession with intent to sell and deliver cocaine, maintaining a dwelling/vehicle for drugs and possession of drug paraphernalia.

The arrests are a result of an undercover operation that began several weeks ago with the assistance of the sheriff's offices in Brunswick and Duplin counties, said Capt. David Ciamillo of the vice and narcotics unit.

The investigation is continuing, said Deputy Charles Smith, a sheriff's office spokesman. "We feel pretty certain there will be additional arrests," he said.

One Man is Arrested After a Drive-By Shooting Puts One Person in the Hospital

About 1:17 a.m., Greensboro police were conducting a surveillance of gang-related drug activity when they conducted a traffic stop.

The driver fled, leading police on a short vehicle pursuit, according to a press release. He ran off the road and crashed, then fled on foot. He was stopped by a police dog a short time later.

Lionel Crispin Damian-Bravo of Raleigh was arrested and charged with possession with intent to sell and distribute marijuana, maintaining a vehicle to keep a controlled substance, speeding to elude, no operators license and two counts of carrying a concealed weapon.

Two handguns, 225 grams of marijuana and \$3,600 in cash were seized from the 2003 Dodge truck he was driving, police said.

Drug suspects face deportation

Nash County deputies on Saturday arrested **Augustin Renteria** and **Jesus Ortiz Rodriguez**, both of Wilson, after allegedly discovering 221 grams of cocaine and more than \$1,500 inside Rodriguez's car.

The men were stopped during a traffic checkpoint on N.C. 58. A consensual search lead deputies to the cocaine stash, officials said. Afterward, both men confessed to being illegal immigrants from Mexico, deputies said.

Renteria, 22, and Rodriguez, 47, each were arrested and charged with one count of conspiracy to traffic cocaine and multiple counts of cocaine trafficking.

Deputies also charged Rodriguez in connection with a March drug violation where officials said 56 grams of cocaine was seized. The arrests were part of a joint effort between the Nash and Wilson counties sheriff's offices, and the Wilson Police Department.

Both men were taken to the Nash County jail, where they are being held under \$500,000 secure bonds.

Driver's blood-alcohol level was 0.31

Mateo pleaded guilty to driving impaired on July 6, and was given a six-month prison term, suspended for two years of probation. Mateo was arrested by a Highway Patrol trooper.

Judge Marion Warren ordered Mateo to use an Interlock device on his steering column while on probation, and to have a blood-alcohol content of "zero" if driving.

Mateo was also found guilty of having no driver's license.

Officers make 'significant' drug bust

A drug raid Wednesday led authorities to a "significant" amount of cocaine and the person they say was selling it. Lt. Shanon Smith of the McDowell County Sheriff's Office said, late Wednesday afternoon, investigators raided the 171 Riverside Park Drive residence of 39-year-old Alejandro Buendias Sanchez.

They located 369 grams, or more than 13 ounces, of cocaine and \$4,380 in cash, according to Smith. He estimated the street value of the drugs at \$13,500. Sanchez was charged with two counts of trafficking cocaine. He was taken into custody in lieu of a \$100,000 bond.

"This was a significant seizure for us," the lieutenant stated.

Scotland Neck man kills wife, self

A Scotland Neck man, in what authorities on Monday declared a murder-suicide, shot and killed his 34-year-old wife Saturday before turning the gun on himself.

Halifax County deputies found **Jesus Flores**, 41, and his wife **Catherine Flores** lifeless Saturday morning at their home off N.C. 125, dead from gunshot wounds to the head, Maj. Bruce Temple said.

An investigation determined Jesus Flores killed his wife and then himself.

Two of the couple's four children were home at the time of the incident but were unharmed, Temple said.

Deputies confirmed Monday the couple had a history of domestic violence.

Autopsies were scheduled for early this week, Temple said.

Man sentenced in crash that killed four people

A Winston-Salem man was sentenced to less than four years in prison after pleading guilty to crashing a car that killed four of his friends last year.

Gerardo Cruz Garcia, 19, pleaded guilty to four counts of involuntary manslaughter in connection with the crash on Yadkinville Road Sept. 2. The crash killed Noe Marroquin, 15, his brother, Sergio, 17, and cousins Ivan Andres Jr., 18, and David Rojo Martinez, 24. Judge Henry E. Frye Jr. sentenced Garcia to a minimum of 33 months and a maximum of 42 months in prison.

There were six people in the car at the time of the crash. Prosecutor Matt Breeding said Garcia went off the right side of the road, overcorrected, and went off the right side, slamming into a stone wall at Forsyth Memorial Park, a cemetery. Investigators found the speedometer of the car stuck at 85 m.p.h.

The four killed died at the scene, and another passenger was seriously injured but survived, Breeding said.

A resident from a nearby home noticed that Garcia was bleeding from the ears and tried to help him, but Garcia walked away from the crash scene. He was not found until the next day. There was a strong smell of alcohol at the scene and beer cans throughout the car, Breeding said. But given how much time passed between the time of the accident and when Garcia was apprehended, it would have been difficult to prove he was impaired at the time of the crash. Otherwise, Breeding said, prosecutors would likely have charged him with a more serious crime. Garcia's attorney, John Barrow, conceded that there were beer cans in the car, but said the group had purchased the beer shortly before the crash and that they were in the car unopened.

Garcia has been in the United States since he was three months old, Barrow said. Federal Immigrations and Customs Enforcement will detain Garcia after he is released from prison and he will be deported to Mexico, Barrow said.

Three arrested, \$112,000 in cocaine seized

Craven County Sheriff Jerry Monette is calling the arrest of three men allegedly involved in cocaine trafficking "large scale players."

Weapons, various drugs and a kilogram of cocaine were seized from the men. At 3 a.m. Wednesday the gig was up for three men in Vanceboro when Craven County Sheriff's narcotics officers, investigators and road deputies rounded up Edward Staton, 28, of 355 Rance Buck Road, and two other men, **Gonzales Sanchez**, 39, of Goldsboro and **Israel Lopez Espenvodia**, 20, of Washington, N.C.

Monette said the office's narcotics unit has been investigation the sale and distribution of cocaine and marijuana for the past week. "We think the cocaine was coming from south of the United States border," Monette said.

During the investigation, Monette said investigators learned that Staton was receiving large quantities of cocaine from two Mexican men. After surveillance Wednesday morning, investigators stopped a white Ford Explorer on Kite Town Road. Sanchez and Espenvodla were inside the car. Investigators searched the car and found 4 ounces of cocaine with a \$12,000 street value. The two were taken into custody and charged with two counts of trafficking cocaine and felony maintaining a vehicle to transport cocaine. They were put in jail with their bail set at \$1 million each. Capt. Joe Heckman said the two men spoke little English.

Meanwhile, Staten was stopped by deputies while driving a Honda Civic and deputies say he was in possession of marijuana, \$3,000 in cash, and drug paraphernalia.

Investigators served a search warrant at Staten's house. When they got inside the house, they found a locked safe. After the New Bern Fire Department used equipment to open the safe, investigators found a kilogram of cocaine with a street value of \$100,000. Investigators also found seven firarms including an SKS rifle, ecstasy pills, prescription pain medicine and marijuana.

Staten was arrested and charged with two counts of trafficking cocaine, possession with the intent to sell and deliver cocaine and marijuana, felony possession of a Schedule I controlled substance, felony possession of cocaine, felony possession of marijuana, and seven counts of possession of a firearm by a felon. Investigators say he faces more charges. He was put in jail with his bail set at \$2 million.

"It happened fast and quick. This was a substantial amount of cocaine. We will probably take this case to federal authorities," Monette said.

Monette said he was going to contact federal immigration officials to find out the two men's legal status for being in the country

Man wanted for questioning in robbery, assault

Martinez is being held in the Iredell County in lieu of a \$400,000 bond while Delpilar's bond is set at \$300,000.

A Mount Olive man was sentenced to more than a dozen years in prison for trafficking methamphetamine in eastern North Carolina.

Bulmaro Brito Morales, 33, pleaded guilty in March to conspiring to possess with the intent to distribute more than 500 grams of a mixture or substance containing methamphetamine, according to a release from U.S. Attorney George E.B. Holding.

He was sentenced Thursday to 14 years, seven months in prison followed by five years of supervised release.

"In the last two or three years we have seen an increase in the use and distribution of methamphetamine," Holding said. "Central and South American drug organizations are increasing their supply of this drug. As seen, investigators' and prosecutors' resources are being focused on this problem. This case is a small part of that effort."

According to Holding, investigators revealed that Morales was responsible for distributing more than 82,000 grams of methamphetamine in the region between 2006 and 2008. When he was arrested in Bladen County, he had 14 grams of methamphetamine, the release said.

Morales' arrest was part of an Organized Crime Drug Enforcement Task Force operation known as "Fire Ants," which investigates the importation and distribution of methamphetamine. To date, the operation has resulted in 12 people pleading guilty and being sentenced in federal court, according to the release.

3 Charged With Trafficking \$100,000 In Cocaine

CHARLOTTE – A federal grand jury in Charlotte indicted seven men Wednesday on one count alleging conspiracy to distribute and possess with intent to distribute at least 1 kilogram of heroin.

The arrests of the men by the Drug Enforcement Administration on June 30 and July 20, 2009, were part of a continuing investigation by a multi-agency Organized Crime Drug Enforcement Task Force in which several federal, state and local law enforcement agencies, including the Charlotte-Mecklenburg Police Department, participate.

According to the U.S. Department of Justice's National Drug Intelligence Center (NDIC) National Drug Threat Assessment 2009, "Mexican drug trafficking organizations will most likely continue to establish new markets for Mexican heroin in northeastern states. Recent encroachments by Mexican heroin distributors into more northeastern drug markets most likely indicate a determination on the part of Mexican drug trafficking organizations to expand Mexican heroin distribution in new market areas."

Other Hispanic, Asian, and African-American traffickers transport South American, Southeast Asian, and Southwest Asian heroin into North Carolina from Miami, New York, New Jersey, and Philadelphia by private vehicles and networks of commercial bus and airline couriers

An undercover agent opened up a package of black tar heroin for Eyewitness News. It's made from opium from poppy plants grown in western Mexico. It's darker than regular heroin.
