A 22-year-old man was arrested Sunday, accused of molesting a 5-year-old relative.

Santiago Garcia Nolberto is charged with first-degree sex offense of a child and indecent liberties with a child.

According to Wilmington Police Department spokeswoman Linda Rawley, the child's father came home at 2:12 p.m. and saw Nolberto standing in front of his daughter with his pants down. When police arrived to the 3700 block of Carolina Beach Road, Nolberto was being chased out of the home by the father.

Officers detained Nolberto. During the course of the investigation, detectives determined Nolberto sexually assaulted the child, Rawley said.

His bail is set at \$1 million.

WINSTON-SALEM — A Kannapolis man has been charged in a child rape case, according to a Winston-Salem Police news release.

The child, a family member, was 9-years-old when the rape started in 2005, according to the release. The rape stopped in 2011.

Eliazar Juan Mendoza, 37, of 723 Evelyn Ave., is charged with: five counts of first degree rape; seven counts of indecent liberties; two counts of first degree sex offense; two counts of statutory rape/sex offense; and two counts of felony child abuse, according to the release.

Mendoza is being held at the Cabarrus County Detention Facility on \$750,000 bail. He is awaiting extradition to Winston-Salem, according to the release.

Police first learned of the rape in August according to the release. Mendoza allegedly raped the child between 2005 and 2011.

Mendoza was arrested at his Kannapolis home on Monday.
