Mendoza is being held at the Cabarrus County Detention Facility on \$750,000 bail. He is awaiting extradition to Winston-Salem, according to the release.

Police first learned of the rape in August according to the release. Mendoza allegedly raped the child between 2005 and 2011.

Mendoza was arrested at his Kannapolis home on Monday.
