## Couple Accused Of Cocaine Trafficking

Police arrested a Newton couple on cocaine-trafficking charges this week after drugs were allegedly found inside their home.

Investigators searched the home of **Manolo Ignacio Martinez-Hernandez**, 20, and his wife, **Amber Jo Martinez**, at 418 East 11th St. in Newton on Wednesday on a search warrant. They seized about eight ounces of cocaine, \$819 in cash, two handguns, drug-packaging materials and other drug paraphernalia from the residence, said Newton Police Chief Don Brown.

He said the drugs were found in two separate areas of the home. Investigators would not comment on the specific locations of the cocaine.

Martinez-Hernandez was charged with two counts of felony trafficking cocaine by possession and one count of felony trafficking in cocaine by transportation. His wife, Martinez, was charged with one felony count of trafficking in cocaine by possession and one felony count of trafficking cocaine by transportation.

Brown said the trafficking charges are derived from the drug-packaging materials that suggest the two were distributing the drugs within the community. He said the drug operation stems from two areas, Newton and Long View.

It's unclear how long the operation has been in business, but it was said by police to be "very organized."

It is unclear how police were made aware of the drug operation, Brown said. Investigators often receive information from informants in the community, he said.

The drug bust was a multi-agency effort including the Newton, Hickory and Long View police departments, as well as the Catawba County Sheriff's Office.

Martinez-Hernandez is being held in the Catawba County jail on \$200,000 bond. Martinez was released from jail on \$10,000 bond. Their first appearance in court was Friday.

## Attempted Rapist Sought By Authorities

Law enforcement investigators are asking for the public's help in identifying an attempted rapist. A 28 year-old woman managed to fight off an attacker outside her home in the West Clayton Mobile Home Park on Old US70 near Clayton around 6pm Thursday. Sheriff's Detective Lt. Chris Strickland said

the victim was outside her home when a man approached her and asked for directions. Seconds later the suspect pulled a knife on the victim, drug her to a wooded area, and tried to sexually assault the woman. A passerby heard the victim scream and came to her aid. The suspect then fled. The assailant is described as a **25- to 30-year-old light skin Hispanic male**, 5 foot 7 to 5 foot 9, last seen wearing a white t-shirt with black letters, blue jeans. The suspect had slick hair, and may have been driving a gray or silver four door vehicle. Anyone with any information about the suspect or the incident is asked to contact Detective Lt. ## **4 Kilos Of Cocaine Seized In Cleveland Area Drug Bus**

The Johnston County Sheriff's Office made a major drug bust Thursday, seizing four kilo of cocaine with an estimated street value of \$240,000. Narcotic agents said the drugs were concealed inside a Chevy passenger car at a garage at 281 Allen Road in the Cleveland community outside of Clayton. Agents executed a search warrant and seized the 4 kilos of cocaine plus a large amount of materials commonly used to package narcotics. Three Hispanic males are in the Johnston County Jail charged with drug trafficking. They include **Freddy Duarte Morales**, 29, and **Celso Morales**, 34, of Allen Road Clayton; and **Heriberto Castro Valladares** of Cornwallis Road, Clayton. Bail for the Freddy and Celos Morales was set at \$1 million each. Valladares was jailed in lieu of a \$600,000 bond. Authorities are also checking to see if the three accused drug traffickers are in the United States illegally

**Bloods** - A Los Angeles-founded gang whose members wear red bandanas and red clothing. The Bloods were created by a group of Crips who broke off from that gang.

**Crips** - This gang started in the late 1960s in Los Angeles. Its members wear blue and refer to each other as "Cuz" (cousin). Their intense rivalry with the Bloods has popularized the initials BK (for "Blood Killer") in Crip graffiti.

**Folk Nation** - An alliance of various street gangs begun in Chicago. The six-pointed Star of David and the pitchfork are common symbols in Folk Nation graffiti.

**MS-13** - A **Hispanic gang** begun in the 1980s by Central American immigrants in Los Angeles, the group's formal name is **Mara Salvatrucha**. Members often get tattoos with gang symbols, including crossbones, devil horns, dice and daggers.

**Sur 13** - This group takes its name from "**Surenos**," the Spanish word for southerners, and formed in Southern California as an alliance **of Mexican-American gangs**. Surenos members wear the color blue, and the number 13 and Roman numeral XIII are commonly used in their graffiti.

### **Recent drug ring arrests part of DEA raid**

Law enforcement officials revealed this week that several recent major cocaine trafficking arrests in Wayne County were related to a roundup of a Mexican-based illegal drug operation known as the **Gulf Cartel**.

A press release from the office of U.S. Attorney General showed arrests in both Wayne and Johnston counties were part of the operation.

According to the release, all of the arrests made in Wayne County were for cocaine trafficking. The men arrested are alleged members of the Gulf Cartel.

At least five people named on U.S. Department of Justice news release were arrested weeks earlier on cocaine charges, according to arrest records of the Wayne County Sheriff's Office.

Members of the Aggressive Criminal Enforcement Team arrested **Hector Ramos Avellaneda**, 23, of Virginia Beach, Va., and **Antione Lambert**, 24, of Brodnax, Va., after a traffic stop.

Three other men, **Juan Acosta Vasquez**, 30, **Reynoldo Garcia Vasquez**, 28, and **Israel Garcio Vasquez**, 22, of Slick Rock Road, were arrested after a raid of their home according to a Sheriff's Office news release.

A member of the county's Aggressive Criminal Enforcement Team said that between the two raids about a kilogram of cocaine was seized.

Only two men named on the Justice Department news release had not appeared in Wayne County Sheriff's Office arrest reports before Sept. 16.

Those men, **Pablo Martinez Avellaneda**, 34, of Magnolia and **Sergio Ramon Perales Reyna**, 20, of Trenton, are charged with trafficking cocaine, according to the Justice Department news release.

## Man Shot During Robbery

May 9, 2009

A Benson man was shot during an alleged robbery in the parking lot of Wendy's on Highway 210 near I-40 Thursday night. **Juan Antonio Batiste**, 21, a former employee at the business, said he went to visit his former co-workers. While exiting the business and walking back to his car, Batiste said two men, both armed with guns, approached him. One reportedly stated, "We want it all," then took \$30 in cash and a cell phone. The victim said he tried to take the gun away from one of the suspects, but during a struggle, the weapon discharged, striking him in the leg. Batiste drove himself to WakeMed in Raleigh where he underwent treatment. The Johnston County Sheriff's Office is investigating the incident.

## \$1 Million In Cocaine Seized In Sampson County

May 9, 2009

The Sampson County Sheriff's Office Highway Enforcement Awareness Team has seized 5 kilos of cocaine on Highway 701. Seven men, most from Raleigh, were arrested. According to sheriff's officials, they were able to seize the cocaine based on an anonymous tip they received. Deputies acted on information received about three vehicles, according to reports, that were involved in transporting cocaine into Sampson County. Deputies saw the three vehicles on U.S. 701 in a business parking lot and stopped them, according to sheriff's Capt. Eric Pope. Subsequently the vehicles were searched and a total of 5 kilos, or 11 pounds, of cocaine valued at \$1 million and three handguns were seized with occupants of all three vehicles charged and jailed. **Ramiro Rivera-Rubio**, 37, of McPhail-Fowler Lane, Clinton; **Jose Joan Cruz Santander**, 29, of Kyle Drive, Raleigh; and **Victor Mendoza Montiel**, 34, of Vintage Road, Raleigh, were charged with trafficking cocaine. **Diego Gonzalez**, 23, of Schonley Drive, Raleigh; **Daniel Bello-Pachew**, 25, of Pointer Drive,

Raleigh; and **Rigoberto Rivera-Leyva**, 25, of Lady Kali Drive, Knightdale, were charged with trafficking cocaine and carrying a concealed weapon. All were held on bonds ranging from \$1 million to \$1.5 million each.

## **Trial Begins For Illegal Immigrant Charged In Crash That Killed 7 Year-Old**

The trial for an illegal immigrant, accused of striking and killing a 7 year-old boy, trying to cross the roadway in front of his grandmother's home last year, began Monday in Johnston County Superior Court. **Hipolito Hernandez**, 31, of Parkertown Road, Four Oaks is charged with second-degree murder, felony hit and run, felony assault, driving while impaired, reckless driving, operating a stolen motor vehicle, and driving without a license. Hernandez ran off Heath Road on April 13, 2008 striking Marcus Lassiter of Selma. The child died the next day at Duke Medical Center after his family made to decision to remove him from life support. Witnesses said Hernandez fled on foot from the crash scene without checking on the condition of the injured child. Law enforcement officers with the help of a Good Samaritan, Allen Hester, caught him about an hour later. **Hernandez had been charged with DWI four times before the fatal crash last year.** Two were dropped, one was pled down to a lesser offense, and the fourth charge was pending in court. Attorney Lee Hatch, according to WRAL, handled both the two DWI cases dismissed against the illegal immigrant. The prosecutor in one of the cases was Cindy Jaeger. They are among six people charged in a ticket-fixing scheme, although the two cases against Hernandez were not part of an SBI investigation that led to their arrests in March.

## **Princeton Man Attacked With Baseball Bat**

Johnston County sheriff's deputies are investigating an assault on Progressive Church Road outside of Princeton. Saturday night, a 35 year-old man, **Jose Maza**, said he was struck in the back of the head with a baseball bat during an altercation with **another Hispanic male**. Maza sustained a serious laceration to his head, but is expected to be OK.

## **SSS Student Charged With Affray**

Detectives with the Johnston County Sheriff's Office have arrested a man they say is responsible for an attempted rape and robbery less than a week apart. Authorities said 29 year-old **Michael Valdez** of Highway 42 in Willow Springs was arrested Thursday for both incidents. On April 24, Valdez reportedly entered the Super 8 Motel on Leon Court at the I-40/NC42 interchange and attempted to overpower a female clerk during a robbery attempt. The victim managed to pull a fire alarm causing the suspect to flee. Six days later, on April 30, Valdez is accused of approaching a woman in the West Clayton Mobile Home Park, on Old US70, pretending to need directions. Once he got close to the woman, he reportedly pulled her into a wooded area and tried to rape the 28 year-old victim. Another person in the park heard the victim's screams and came to her aid. Valdez is charged with attempted first-degree rape, first-degree rape, and attempted common law robbery. He is being held in the Johnston County Jail without bail.

## **\$91,000 in cash, marijuana seized in drug bust**

NEWTON - A multi-agency operation netted Catawba County law enforcement one accused drug dealer, 35 pounds of marijuana and \$7,070 in cash in a recent bust. The marijuana has a street value of \$84,000, said Chief Deputy Coy Reid of the Catawba County Sheriff's Office.

## **Suspected gang members sentenced to prison in 2006 shooting**

Four men are headed to prison for trying to kill a store owner three years ago.

A jury convicted **Carlos Hernandez**, 26, last week of attempted murder, assault with a deadly weapon with intent to kill inflicting serious injury and robbery with a dangerous weapon. He was accused of shooting Santiago Mungaray in the head on Dec. 28, 2006, according to the Rockingham County District Attorney's Office.

Judge James Webb sentenced Hernandez to 20 to 26 years in prison. His co-defendants, **Isreal Rodriguez** and **Josue Rodriguez**, both 26, and **Jose Ocampo**, 43, pleaded guilty to the same charges and received 11 to 14 years in prison. Mungaray will not recover from his injuries, according to a news release from the District Attorney's Office. District Attorney Phil Berger Jr. said he can breathe on his own but is fed through a feeding tube.

Authorities said the four men stole jewelry from Mungaray's store, La Autentica, on Turner Drive in Reidsville. Mungaray was shot in the head during the robbery. They fled to New Jersey, where authorities said the gun used in the robbery was found during a traffic stop. They were extradited in 2007, and immigration detainers were placed on them. The news release indicated **the men belong to the MS-13 gang.**

### **Alleged attempted rapist's case dismissed after state's only witness flees**

BOLIVIA—The 12-year-old victim of an alleged attempted first-degree rape returned to her native Mexico before **Virginio Colin Isidoro** went to trial, leaving the district attorney's office without its only witness and without a case.

Assistant District Attorney Meredith Everhart said all charges against 37-year-old Isidoro were dismissed when the girl left the country with her mother and sister, before the trial began in April.

The Brunswick Beacon does not identify victims of sex crimes.

In September 2008, Isidoro, who was living in Boiling Spring Lakes, was charged with attempted first-degree rape, taking indecent liberties with a child and felony disseminate obscenity—all of which were dismissed when the state's only witness, the alleged victim, left for Mexico.

Everhart described the situation as "frustrating."

"If there had been additional evidence, it would have depended on that," Everhart said about proceeding with the trial without the alleged victim in attendance. "It was an attempted rape. There was nobody else around when it happened. There were no other witnesses," she said.

### **Kilo Of Cocaine Seized In Sampson County**

Investigators from the Onslow County Sheriff's Office, the State Bureau of Investigation, Immigration and Customs Enforcement and the Sampson County Sheriff's Office Special Investigations Division seized a kilo (2.2 pounds) of cocaine near Harrells, according to Sampson Sheriff's Capt. Eric Pope.

Gonzalez was charged with one felony count of disseminating obscene material to a minor, three felony counts of identity theft and one felony count of obtaining property by false pretenses. He is being held under \$75,000 secured bond at the Hoke County Detention Center.

Peterkin said the 'sexting' craze hasn't been an issue here as of yet, but said it's always illegal to send nude photos to underage people or of underage people via a cell phone. "When you are talking about children, it's a whole different ballgame," Peterkin said.

Tuesday night, officers passed out flyers at the intersection of Haywood and Cabarrus Streets and stopped motorists asking questions about the shooting.

## **Raleigh Cab Driver Shot**

RALEIGH (WTVD) -- Raleigh police are investigating the shooting of a cab driver. Police say the driver of a Taxi Fiesta cab was shot around 4 a.m. Wednesday.

According to police, 27-year-old **Juan Rayo-Reyes** was attacked by three men while sitting in his cab outside the Birch Ridge Apartments located near Bragg St. and Angleus Ave.

"He had completed the fare, was returning home [and] as he parked his vehicle, exited his vehicle, he was accosted by the three suspects," Captain Norman Grodi of the Raleigh Police Department said. Reyes was rushed to the hospital but his condition is unknown.

The incident took place just a few blocks from the scene of a shooting that happened early Tuesday morning. In Tuesday's shooting, 18-year-old **Rodriguez Burrell** died after being shot several times. Police have no suspects in his death.
