## Virginia man faces drug charges after stop in Buncombe County

Deputies say they caught a Virginia man with 40 pounds of marijuana during a traffic stop on Interstate 26.

**Jose Emilio Herrera Lopez**, 23, of Independence, Va., was charged with three counts of trafficking in marijuana, possession with intent to sell and deliver marijuana and maintaining a vehicle for drugs, according to arrest warrants.

Authorities also determined the suspect is in the country illegally and put an immigration detainer on him, Lt. Ross Dillingham said.

Dillingham said deputies with the Buncombe-Henderson highway drug interdiction team pulled Lopez over about 7:30 p.m. Wednesday at mile marker 32 in Buncombe County.

Dillingham said the marijuana has an estimated street value of \$96,000. Lopez was jailed in Buncombe County under a \$125,000 bond.

Dillingham said he wouldn't release any other information about the case.

The interdiction team was created by Buncombe Sheriff Van Duncan and Henderson Sheriff Rick Davis in 2009 to curb the transportation of illegal drugs on I-26 and Interstate 40. Since then the team has seized more than \$5 million in drugs and money related to the sale of drugs in the two counties, Dillingham said.

## Two men face drug charges in Moore County

CARTHAGE - A federal drug investigation in Moore County has led to the arrest of two men and the seizure of nearly \$100,000 worth of illegal drugs.

**Jose Inocente Dominguez Martinez**, 27, of the 400 block of Virginia Avenue in Robbins, and **Victoriano Escamilla Olvera**, 35, of the 200 block of Tyler Lane in Robbins, were charged Wednesday with distributing powder cocaine and selling and distributing firearms, according to a news release from the Moore County Sheriff's Office.

Sheriff Lane Carter said the six-month investigation ended Wednesday when lawmen raided the residences of the two men.

Lawmen seized 540 grams of powder cocaine, 10 pounds of marijuana, five firearms, four motor vehicles, \$4,418 and drug paraphernalia, according to the release.

The estimated street value of the drugs is \$98,800, Carter said.

Martinez and Olvera were taken to Greensboro and placed in the custody of the U.S. Marshal's Service.

Multiple state and federal agencies participated in the investigation, including the Sheriff's Office and U.S. Drug Enforcement Administration.

## Driver charged after bad wreck on I-485; 8 injured expected to survive

CHARLOTTE- Three people were ejected from an SUV and five others were also injured after a wreck on what one trooper called a dangerous curve in northern Charlotte.

All eight people riding in the overcrowded SUV are expected to survive -- their injuries ranged from scratches to a broken arm, said Trooper M. Heon, who is investigating the crash. They were taken to Carolinas Medical Center.

The wreck happened around 9:30 a.m., on the ramp that leads from Interstate 485 to I-77 just north of Northlake Mall.

The SUV's driver, **Arturo Cinto**, 33, was arrested and charged with driving without a license, exceeding a safe speed and overcrowding a vehicle. He was in Mecklenburg jail Wednesday afternoon, but his bond information wasn't immediately available.

Troopers **said none of the eight people in the SUV**, which was on a 2,000-plus mile journey from Phoenix, **could prove they were in the country legally**.

## Nearly 600 immigrants arrested in federal operation

HICKORY - Nearly 600 immigrants with criminal records were arrested in the Southeast in three days in an operation conducted by U.S. Immigration Customs Enforcement (ICE), including 17 in Hickory.

Operation Cross Check, as it was called, was carried out Wednesday through Friday and resulted in the largest number of arrests ever, said Barbara Gonzalez, the southern regional communications director for ICE. The operation was carried out in Florida, Georgia, South Carolina, **North Carolina**, Arkansas, Alabama, Louisiana, Tennessee, Mississippi and Puerto Rico, with help from area law enforcement.

"All had been convicted of felony crimes and served sentences and were eligible for removal," Gonzalez said. "Some were here lawfully, but because of their convictions, they were eligible for revocation."

She said many of the people arrested were here illegally. The people arrested are from 60 countries, representing Latin America, Asia, Europe, Eastern Europe, the Middle East and Africa. Only 55 of the 596 people arrested were women. The area with the highest number of arrests was in Florida and Puerto Rico, where ICE arrested 258 people.

**GREENSBORO, N.C.** - Guilford County sheriff's deputies and Immigration and Customs Enforcement officers were shot at Friday night while searching a Greensboro home where they believe a human trafficking victim was being held.

Guilford County sheriff's deputies were conducting a search with ICE officers at 700 N. English St. in Greensboro around 11 p.m. Friday when they say a man fired two shots at them. Deputies returned fire, but no one was injured.

Col. Randy Powers with the Guilford County Sheriff's Office says they had received information that the homeowners were allegedly running a brothel, which led to their search.

While searching the residence and conducting multiple interviews, deputies found a juvenile in the house they say was a victim of human trafficking. Deputies say she was removed from the home and is working with ICE through the investigation.

Deputies identified the shooter as **Reyna Isabel-Reyes Caballero**, 37, and charged him with assault with a deadly weapon with intent to kill. Detectives are also looking at charging Caballero with human trafficking law violations at the state level.

Col. Powers says Caballero, from Honduras, **and three others in the house are illegal immigrants**. Caballero is being held in the Guilford County Jail under a \$250,000 bond, but ICE officials are detaining him there while the investigation continues.

Martinez-Garcia blew a .08 blood alcohol level during that 2002 stop and was driving without a license. He had an open container and was driving after consuming while under the age of 21.

He got his second DWI in August 2005, again driving without a license, with a blood alcohol content level of .21. He went to jail for 60 days and got 12 months probation.

In November 2006 he was charged with possession of cocaine. The charge was dropped, but he spent 45 days in jail on a drug paraphernalia charge and got 24 months probation.

In August 2007 he was charged with driving without a license again and resisting a public officer, but both charges were dismissed.

Martinez-Garcia still had a revoked license when got his third DWI in August 2007. That conviction sent him to jail for one year.

Martinez-Garcia did not receive felony charges until his fourth DWI in April 2008, which landed him 12 to 15 months in jail for habitual impaired driving.

**Aurelio Pineda Montano**, 45, of 4311 Colier St., Houston, Tx., is being held in the Richmond County

Jail on a felony charge of manufacturing marijuana. He was jailed on a \$100,000 bond.

Sheriff Dale Furr characterized the number of plants seized as “an extremely large amount.”

According to Montano’s arrest report, the Richmond County Vice/Narcotics Unit received information about an illegal marijuana growing operation in the forest along Holly Grove Church Road.

The Narcotics Unit, along with the RCSO Special Response Team, entered the woods and found Montano watering the marijuana plants.

Along with the 6,770 plants, several items used for their cultivation were seized.

Investigators said the plants were three to four inches tall, and said the operation had been recently set up.

A mature marijuana plant’s street value is estimated at between \$1,500 and \$2,000 according to the State Bureau of Investigation.

The North Carolina Highway Patrol assisted the sheriff’s office during the seizure.

## 17 Pounds Of Meth Found In Horse Saddles

DUPLIN COUNTY, NC - Lawmen say it is one of the biggest drug busts ever in Eastern Carolina, and among the largest in the state.

Duplin County authorities say they have seized a total of 17 pounds of meth that was hidden in horse saddles. The value of those drugs is believed to be in excess of \$1 million.

**Jose Almendarez-Carcamo** of Magnolia is in jail on a \$1.5 million bond. Sheriff Blake Wallace says Carcamo is an illegal immigrant, believed to be from Honduras.

The sheriff says others are believed to be involved and more arrests are possible. "I look at it not only as a victory for law enforcement, but the community as well. This is meth that would've ended up in the hands of our children. So any time we can keep this poison off the streets, then I think we've done a good days work," said Sheriff Mason.

Carcamo was arrested last Tuesday near Rose Hill when authorities say they found three pounds of meth. An additional 14 pounds of meth was later uncovered.

Wallace says their investigation started when his department received a tip about meth trafficking in the area.

## Greensboro man convicted on child rape charges

According to police warrants, Levanderia-Hernandez, an undocumented immigrant, had sex with a girl between January 2002 and December 2005, starting when the girl was 9 years old.

## **Charlotte ICE gang operation yields 12 arrests**

CHARLOTTE, N.C. - U.S. Immigration and Customs Enforcement (ICE) agents assigned to the Charlotte Gang Unit continue making arrests in North Carolina with its recent weekend effort yielding 12 arrests and the seizure of cocaine, marijuana and brass knuckles.

Among the 12 arrests last weekend were four gang members and affiliates: one Asian Boyz gang member, **two MS-13 gang members and one MS-13 affiliate**. All four are foreign-born nationals from **Vietnam, Uruguay and Honduras**. One is a naturalized U. S. citizen, one has lawful residency status and **the other two are illegally present in the country**. Two face state charges and two face immigration charges.

The additional eight individuals arrested face various charges ranging from immigration violations to drug and weapons charges. One individual arrested had an outstanding warrant issued by the state.

One is a U. S. citizen and the others are **illegal aliens from Guatemala, Honduras and El Salvador**.

## **Three cousins die in Sanford crash; police seek driver**

SANFORD, N.C. — Three cousins died in a crash on Jefferson Davis Highway early Saturday, and Sanford police were searching for the driver of the burgundy Nissan truck, according to a police report.

**Edwin Perez Hernandez**, who was believed to be in his 20s or 30s, **Claudia Baudililo Hernandez**, 34, and **Fermin Patrocinio Perez**, 27, died in the crash, according to police. The cousins all lived at 1212 Burns Drive in Sanford.

"The roof was caved in all the way to the dashboard, down to the backseat," Capt. David Smith of the Sanford Police Department said.

Crash witness Max Lino said he saw **the driver, Hugo Alfredo Hernandez** of 1212 Burns Drive, "crawl out of the truck and stagger off toward Spring Lane."

Police said it appeared that the truck was traveling south on Jefferson Davis Highway when it went off the road, skidded down an embankment, overturned twice and ended up on Douglas Drive some time before 1:30 a.m.

"He was going way too fast and jumped the curve," Lino said.

Lino said after he saw the truck flip, he ran to help. A man, he thinks was the driver, asked him to take the injured home. Lino said he called 911 instead.

"After that, he (the driver) started walking away from the scene," Lino said.

Smith said two of the victims died at the scene and another died a short time later at Central Carolina Hospital.

Police brought in dogs to try and locate the driver, who is believed to also be badly injured. He has not been found.

## **Marijuana smell leads to seizure of 85 plants**

BURLINGTON — Alamance County authorities seized 85 marijuana plants and other drugs when they responded to a domestic disturbance Tuesday.

The Alamance County Sheriff's Office said deputies went to 1734 Haw River-Hopedale Road on Tuesday to investigate a domestic dispute. No one answered the door, but deputies smelled marijuana and got a search warrant.

Inside, according to the sheriff's office, were the marijuana plants, 1.06 kilograms of packaged marijuana, 53 methadone pills and more than \$3,000 in cash.

Deputies later got an arrest warrant for the man who lives there: 28-year-old **Anthony Brandon Aguayo**. He faces five criminal charges, including manufacturing marijuana and possession of marijuana with intent to distribute.

Aguayo, who is Hispanic, has a previous arrest for possession of drugs and carrying a concealed weapon in 2004.
