RALEIGH (WTVD) -- Two teenage brothers will spent at least the next quarter of a century in prison for the gang related murder of another Raleigh teen.

The now 14 and 17 year olds avoided a first degree murder trial by accepting a second-degree plea deal.

Brayan Hernandez-Sierra was just 13 years old when he shot and killed Fernando Garibay-Benitez, a rising tenth grader at Millbrook High School, in August 2012. It happened in the 3800 block of Rolling Green Court ni north Raleigh as the brothers were leaving an apartment complex in their mother's van.

Prosecutors say Brayan was encouraged by his big brother to ask two teens on the street what gang they were in.

One boy responded with the name of a rival gang. He got away but Garibay-Benitez, who apparently had no gang affiliation, was shot in the head by Brayan.

Ceferino Seferino and Brayan Hernandez-Sierra both pleaded guilty to second-degree murder and conspiracy to commit first-degree and assault with a deadly weapon.

Seferino was sentenced to between 26 and 33 years, while his brother Brayan was sentenced to between 30 and 38 years.

"We are very fortunate that we were not maimed in any way," McClure said.

Minutes later, police said the spree ended when they made their way to Oneida Road where they pulled a 59-year-old woman out of her Lexus, stole her purse and drove off with her car.

Neighbors in the area who didn't want to be identified said they were frightened.

"I have a lot of concerns about what goes on in this neighborhood," one neighbor said.

Investigators say they arrested Santiago after they pulled over a vehicle he was in.

NC Man Faces Charge of Attempting to Join Al-Qaida

A North Carolina man is facing federal charges that he sought to join an al-Qaida-linked militant group fighting the regime of Syrian President Bashar Assad.

Basit Javed Sheikh, 29, of Cary, is charged in a federal criminal indictment with attempting to provide material support to a foreign terrorist organization. He was arrested on Nov. 2 before boarding the first of a series of flights that would take him to Lebanon.

Sheikh told an FBI informant he was going to join the group called the Nusrah Front in Syria, an FBI agent said in a sworn affidavit obtained by The Associated Press.

The <u>Pakistan native</u> was assigned two federal public defenders to represent him during a court hearing last week. The defense attorneys could not be reached Monday because their office was closed for the Veterans Day holiday. Messages to phone numbers listed for Sheikh were not returned Monday.

For five months this year, Sheikh, also known as Abdul Basit, posted messages and videos on Facebook expressing support for jihadi militants fighting Assad's forces in the bloody, 3-year-old Syrian civil war that has killed more than 100,000 people, said the affidavit signed by FBI Special Agent Jason Maslow.

In August, Sheikh began an online relationship with an FBI informant who used a Facebook page promoting Islamic extremism, the affidavit said.

Sheikh told the informant in early September that he'd bought a one-way ticket to travel to Turkey in hopes of making contact with people who would get him to Syria. Sheikh said he backed out because "he could not muster the strength to leave his parents," the affidavit said. Sheikh said he had traveled to Turkey last year hoping to join the fight in Syria, but became dispirited by his experience with people who claimed to be part of the U.S.-backed Free Syrian Army.

Four years ago, eight Raleigh-area Muslims were arrested on charges they were behind a homegrown terror plot to attack the U.S. Marine Corps base at Quantico, Va., and perceived overseas enemies of Islam. Seven either pleaded guilty to terrorism-related charges or were convicted at trial. The last, Jude Kenan Mohammad, was among four Americans confirmed as being killed by drones in either Pakistan or Yeman since 2009, the Obama administration said in May.

indicted in August 2012 on a count of first-degree murder but pleaded guilty Monday morning to the lesser charge as part of a deal with prosecutors.

Tejada, who walked into the Pitt County Detention Center courtroom in an orange inmate jumpsuit, was sentenced to 20-25 years in prison, the maximum term, in line with pleas from Cutler's family to Judge Marvin K. Blount III.

Columbus lawmen seize marijuana; man faces drug charges

WHITEVILLE - One man was arrested after Columbus County lawmen searched a home and found an estimated 30 pounds of marijuana, the Sheriff's Office said.

Daniel Donald Battista, 52, was arrested inside the house on Schoolhouse Lane after detectives conducted a search and found 57 marijuana plants in pots and other items used in the growing process, Lt. Steven Worthington said in a news release.

Battista was charged with trafficking marijuana by manufacturing, trafficking by possession and maintaining a dwelling for a controlled substance. He was released from the Columbus County Detention Center under a \$5,000 bond.

The investigation followed a resident's complaint in the Thompson Town/Pleasant Hills Community.

Detectives seized growing lights, fertilizer, potting soil and other items. The plants were sent to the State Bureau of Investigation crime lab for analysis, Worthington said.

Battista also has a home in Longs, S.C., Worthington said. Detectives from the Horry County Solicitors Task Force went to the home on Winter Creeper Drive and located "an additional amount of finished product" and Battista's wife.

Additional information was not immediately available from the Horry County Solicitor's Office.
