Ramos was being held at the Wake County Detention Center Wednesday night, his bail set at \$200,000.

#### Illegal alien charged with child rape in North Carolina

On Sunday, police in Greenville arrested **Edmundo Gonzalez-Cinta**, 50, after he reportedly raped a young girl.

Police have released very few details about the crime, in order to protect the victim's identity.

Gonzalez-Cinta has been charged with <u>first degree child rape</u> and is currently being held at the Pitt County Detention Center of \$500,000 bond as well as an <u>immigrationdetainer</u>.

Pitt County detention officers have confirmed that Gonzalez-Cinta is in the country illegally.

#### Hampstead man pleads guilty to sex crimes with disabled minor

PENDER COUNTY, NC (WWAY) -- A Hampstead man could be deported after pleading guilty to sex crimes against a disabled child.

The District Attorney's Office says Victor Saravia Vasquez, 40, pleaded guilty to two counts of indecent liberties with a child and one count of misdemeanor secret peeping. A judge sentenced him to two consecutive sentences of 13-16 months in prison. Vasquez must also register as sex offender for 30 years and may be deported as a result of this conviction.

Prosecutors say in the fall of 2010 and the winter of 2011, Vasquez lived with the victim's family and shared a bedroom with the victim. The victim, who is developmentally disabled, was 15 years old when Vasquez first began forcing him to perform oral sex and later anal sex. The DA says he intimidated the victim and made him promise not to disclose the abuse.

#### Man Charged With Sexually Assaulting 23 Month-Old Baby

A 23 month-old child was hospitalized Monday after being the victim of an alleged sexual assault.

WTSB News has learned Johnston County sheriff's deputies were called to a home on Packing Plant Road near Smithfield for a disturbance. When officers arrived, Sheriff's Captain A.C. Strickland said they learned a 53 year-old man at the scene had allegedly sexually assaulted a small child at the home.

**Abelardo Gordillo Rodriguez**, 53, of Packing Plant Road, Smithfield was charged with taking indecent liberties with a child. He was booked into the Johnston County Jail under a \$100,000 bond.

Captain Strickland said the child was transported to the hospital for medical evaluation. The Johnston County Department of Social Services was also notified of the incident.

#### Cumberland County man charged with sexually assaulting 14-year-old girl

PARKTON, N.C. — A 20-year-old Cumberland County man will make a first court appearance Wednesday on charges that he sexually assaulted a 14-year-old girl.

**Shawn Rosario**, of 4517 Black Stallion Court in Parkton, is <u>charged with three counts of statutory rape of a minor, three counts of taking indecent liberties with a minor and second-degree kidnapping.</u>

According to investigators, Rosario had sexual relations with the girl in August. The victim told detectives the assaults happened in Rosario's car when it was parked between two vacant homes in her neighborhood.

Rosario was released from the Cumberland County jail on a \$60,000 bond. He was scheduled to appear in court Wednesday afternoon.

#### **Ugandan National Charged With Sex Crimes In Clayton**

On October 15, he was taken into custody by the Wheeling Police Department without incident.

Musoke was held in the Cook County Jail until he was extradited back to Johnson County, where <u>he is now</u> facing charges of two counts of first degree sex offense with a child.

#### 23 defendants plead guilty in Human/Sex Trafficking Investigation 'Dark Night'

United States Attorney Edward J. Tarver announced on September 25 that Joaquin Mendez-Hernandez, a/k/a "El Flaco," 35, formerly of Mexico, pled guilty last week before Senior United States District Court Judge B. Avant Edenfield for his role in a <u>sex trafficking organization</u> which operated in Savannah, Georgia, parts of Florida, South Carolina and <u>North Carolina</u>, and in Mexico. Mendez-Hernandez faces a possible life sentence for his role in the sex trafficking organization.

Each of the 23 defendants charged earlier this year in an operation dubbed 'Dark Night' have pled guilty. Two additional defendants, Eugenio Prieto-Hernandez and Daniel Ribon-Gonzalez, remain fugitives. Operation Dark Night represents the largest sex-trafficking investigation ever prosecuted in the Southern District of Georgia.

According to evidence presented during numerous guilty pleas, local and federal law enforcement agencies identified and dismantled an international sex trafficking enterprise that spread from Mexico to Savannah, Georgia. Members of the organization enticed women from Mexico, Nicaragua and elsewhere to travel to the United States with false promises of the American dream.

Once inside the United States, these women were threatened and forced to commit acts of prostitution at numerous locations in Savannah and throughout the southeast. Women were forced to engage in sexual activity with as many as 30-50 people a day. To make sure the women complied, members of the organization threatened the women, used violence against the women, and held children hostage in Mexico. Members of the organization would also trade their victims to other members who operated in other states.

United States Attorney Edward Tarver stated, "It is with great pride that I announce the convictions of all of the defendants who were indicted and arrested in connection with 'Operation Dark Night.' This case serves as an example of how local and federal law enforcement can work together to rescue women, save lives, and prosecute criminals. In this case, justice was swift; and we expect the punishment to be severe."

"The conviction of the monsters arrested in this heinous sex trafficking scheme marks the end of a life of misery inflicted on these innocent victims of human trafficking. The perpetrators, ranging from street-level customers to international sex traffickers, will be held accountable for their repeated victimization and exploitation of these vulnerable women," said Brock D. Nicholson, Special Agent in Charge, Homeland Security Investigations (HSI) Atlanta.

"We are deeply gratified by the significant support we received from our law enforcement partners, non-governmental service organizations and the U.S. Attorney's Office for the Southern District Georgia for bringing Operation Dark Night to a successful conclusion."

Cruz was arrested at the scene and <u>charged with discharging a firearm into an occupied dwelling, a felony.</u>
<u>Lt. R.K. Powell said Cruz was under the influence of alcohol at the time of the alleged incident.</u>

Cruz was booked into the Johnston County Jail in lieu of a \$100,000 bond

When they arrived, they found **Lorenzo Puebla Hernandez**, 47, of Danube Lane, who had been shot. Hernandez was taken to the hospital, where he died Saturday morning.

Hernandez was walking back to his apartment when the shooting occurred, according to investigators. No charges have been filed at this time.

Authorities are asking for assistance in locating two suspects in the case: **Gabriel Yanez**, 25, (pictured) and **Bernabe Puebla Rodriguez**, 46, both Hispanic males. The Nash County Sheriff's Office has outstanding warrants for both men charging them with attempted first-degree murder.

#### 2 teens arrested in shooting of off-duty CMPD officer

Two teen-agers were arrested Sunday evening and charged in connection with the shooting of an off-duty Charlotte-Mecklenburg police officer during an apparent home invasion earlier in the day.

Detectives arrested Kevin Watson McClary, 19, and Mauricio Gabriel Salazar-Peiti, 17, and they say McClary had been wanted on additional robbery warrants.

According to police, McClary was the man who broke into the southwest Charlotte apartment and shot Officer Jon Dunham during an attempted robbery about 6 a.m.

Salazar-Peiti was accused of a number of accessory-after-the-fact offenses.

Dunham is recovering from his wounds in a Charlotte hospital.

McClary was taken into custody without incident Sunday evening by detectives and charged with two counts of armed robbery, attempted murder, assault with a deadly weapon with intent to kill inflicting serious injury, first-degree burglary and possession of a firearm by a convicted felon.

Salazar-Peiti voluntarily went to CMPD headquarters late Sunday and was <u>charged after being interviewed by detectives</u>. He faces two counts of accessory after the fact armed robbery and one count each of accessory after the fact assault with a deadly weapon with intent to kill, accessory after the fact first-degree <u>burglary</u>, and felony possession of stolen goods.

"Additional charges are pending for both suspects," said Officer Robert Trietley, a CMPD spokesman.

Dunham was listed in stable condition early Monday.

The shooting happened in the 6600 block of Montcrest Drive, in an apartment complex near where Old Pineville Road meets Archdale Drive.

Dunham's son was in the apartment at the time but was not injured.

Dunham has been on the police force since 2008 and is assigned to the Metro Division.

Detectives questioned other residents of the apartment complex Sunday morning, and police used dogs and the police helicopter to search for the suspect

The boys – Daniel Isai Banegas Diaz, 6, and Jeremias Isaac Banegas Diaz, 5 – were with Selma Diaz and were not harmed, police said.

Court records show a judge granted exclusive temporary custody of them to their father, Roberto Banegas, after he claimed <u>Selma Diaz has bipolar disorder and tried to kill herself in March by jumping in front of a car with her oldest son in hand</u>.

The parents were scheduled to attend a mediation orientation on Oct. 3.

#### Authorities search for Statesville man they say is linked to drug cartel

Iredell County sheriff's investigators have arrested one suspect and are searching for another one in a cocaine and methamphetamine distribution and smuggling ring linked to the Mexican drug cartel, Sheriff Phil Redmond said.

An investigation over several years by the sheriff's narcotics division and federal Homeland Security agents uncovered a drug smuggling ring controlled by a family that moved to the Statesville area, Redmond said.

Sheriff's detectives and federal agents conducted undercover drug buys of about 100 grams of cocaine with a street value of about \$25,000, the sheriff said.

Warrants were issued by an Iredell County magistrate for the arrests of **Juan Carlos Torres** Jr. **and Monica Renteria**, both of Statesville.

Renteria, 25, was arrested and charged with two counts each of trafficking cocaine and conspiracy to traffic in cocaine. She is in jail under a \$500,000 secured bond.

<u>Torres, 22, is charged with six counts of trafficking cocaine</u>. Anyone who knows his whereabouts is asked to call the Iredell County Sheriff's Office at 704-878-3180 or Iredell County Crime Stoppers at 704-662-1340.

Redmond said several others have been charged in the case across North Carolina and that more arrests are expected.

#### Durham police seize nearly 8 pounds of cocaine; pair charged

**Guadalupe Garcia-Martinez**, also of North Hyde Park Avenue, was **charged with conspiring to traffic cocaine.** She was in the Durham County jail under a \$500,000 bond.

Authorities said the drugs are worth about \$70,000 on the street.

The CMPD major crash investigation unit is investigating. Police said they believe speed was a factor in the crash

The suspect's face was splashed across television news stations and newspapers this week as investigators tried to learn his identity. The photos appear to be video camera stills snapped as he pushed a cart at a Walmart store.

Police say those images helped identify the suspect, who "was discovered deceased from what detectives are investigating as an apparent suicide," according to a statement from police.
